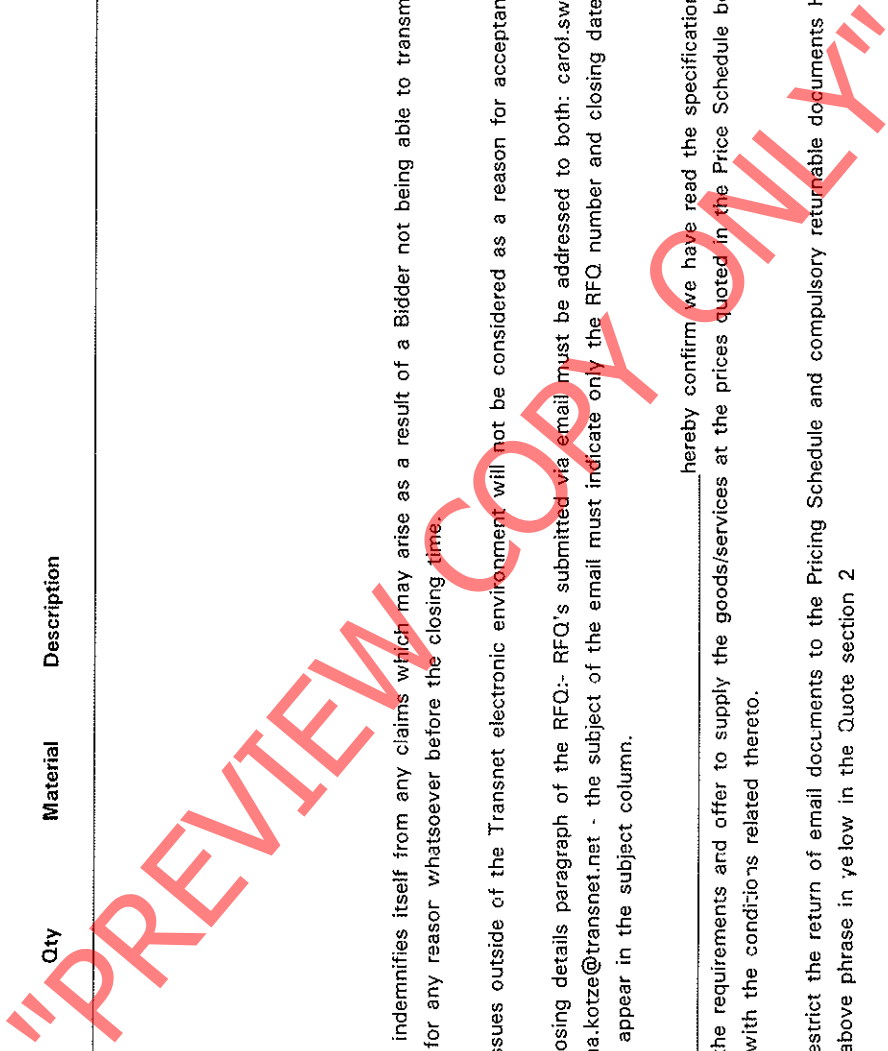

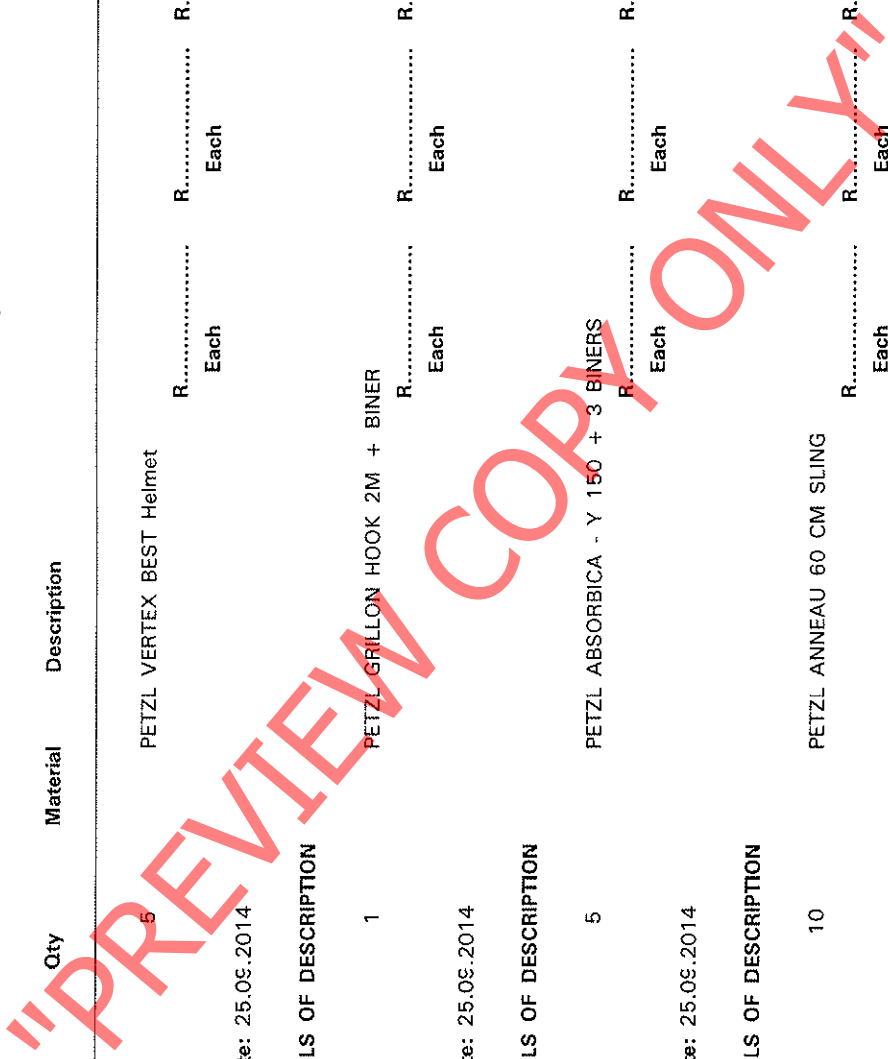

## 1 Broad-Based Black Economic Empowerment [B-BBEE]

Transnet fully endorses and supports the Government's Broad-Based Black Economic Empowerment Programme and it would therefore prefer to do business with local business enterprises who share these same values. Transnet will accordingly allow a "preference" to companies who provide a B-BBEE Verification Certificate. All procurement transactions will be evaluated accordingly.

### 1.1 B-BBEE Scorecard and Rating

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its Regulations, Respondents are to note the following:

- Proposals will be evaluated on price which will be allocated 80 points and preference which will be allocated 20 points, dependent on the value of the Services
- The 80/20 preference point system applies where the acquisition of the Services will be less than R1 000 000.00.
- If the 80/20 preference point system is stipulated and all Bids received exceed R1 000 000.00, the RFP will be cancelled

In compliance with the Government Gazette No 34612, Notice No. 754 dated 23 September 2011, as from 1 October 2011 valid B-BBEE Verification Certificates must be issued by:

- a) Verification Agencies accredited by the South African National Accreditation System [SANAS]; or
- b) Registered Auditors approved by the Independent Regulatory Board of Auditors [IRBA], in accordance with the approval granted by the Department of Trade and Industry.

Enterprises will be rated by such agencies based on the following:

- c) **Large Enterprises** [i.e. annual turnover greater than R35 million]:
  - Rating level based on all seven elements of the B-BBEE scorecard
- d) **Qualifying Small Enterprises – QSE** [i.e. annual turnover between R5 million and R35 million]:
  - Rating based on any four of the elements of the B-BBEE scorecard
- e) **Exempted Micro Enterprises – EME** [i.e. annual turnover less than R5 million]:

In accordance with B-BBEE Codes of Good Practice [Statement 000, Section 4], any enterprise with an annual total revenue of R 5 million or less qualifies as an EME.

- Automatic rating of B-BBEE Level 4 irrespective of race or ownership
- Black ownership greater than 50% or Black Women ownership greater than 50% automatically qualify as B-BBEE Level 3

Sufficient evidence to qualify as an EME would be a certificate (which may be in the form of a letter) from an auditor or accounting officer or a certificate from a Verification Agency accredited by SANAS. The certificate must confirm the company's turnover, black ownership / black female ownership and B-BBEE status level.



Respondents are required to furnish proof of the above to Transnet. [i.e. a detailed scorecard as stipulated above in respect of Large Enterprises and QSEs, or a certificate in respect of EMEs].

Transnet will accordingly allocate a maximum of **20 [twenty] points** in accordance with the **80/20** preference point system prescribed in the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its Regulations to the Respondent's final score based on an entity's B-BBEE scorecard rating.

N.B. Failure to submit a B-BBEE certificate, which is valid as at the Closing Date of this RFP, will result in a score of zero being allocated for B-BBEE.

## 2 Evaluation Criteria

Transnet will utilise the following criteria in choosing a Supplier/Service Provider:-

- Weighted evaluation based on 80/20 preference point system:

**Transnet will utilise the following formula in its evaluation of Price:**

$$PS = 80 \left( 1 - \frac{Pt - Pmin}{Pmin} \right)$$

Where:

$Ps$  = Score for the Bid under consideration  
 $Pt$  = Price of Bid under consideration  
 $Pmin$  = Price of lowest acceptable Bid

- B-BBEE status of company

Preference points will be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

## SCHEDULE OF REQUIREMENTS FOR FALL ARREST KITS

### 1. SCOPE

This schedule covers the requirements of Transnet Freight Rail for the supply of 5 PETZL Fall Arrest Kits with accessories. These kits will be used for work positioning and fall arrest.

### 2. COMPLIANCE

2.1. Tenders must comply with all the specifications and requirements as indicated in this document. Any deviation from this specification must be indicated in the tenderer's submission document.

2.2. Fall Arrest Harnesses must be CE EN 361,358 and 853 certified and Transnet reserves the right to call for samples to be evaluated for compliance with Transnet requirements.

2.3. Specifications and brochures must be provided for all the equipment quoted on.

2.4. Life span on Fall Arrest Harnesses must be a minimum of 10 years.

### 3. SERVICE CONDITIONS

3.1. The equipment must be suitable for continuous operation under the following conditions:

Ambient temperature : -10° to 60° Celsius

Air pollution : Heavily saline laden industrial and locomotive fumes.

Relative humidity : As high as 95%.

3.2. All components and parts must be manufactured and installed to ensure reliable operation under these conditions.

#### 4. GENERAL REQUIREMENTS FOR THE FALL ARREST HARNESS

- 4.1 Must have wide, semi-rigid waist belt and leg loops for excellent support that are contoured and lined with breathable perforated foam for maximum comfort when suspended.
- 4.2 The shoulder straps must be widely spaced to reduce neck chafing.
- 4.3 Waist belt and shoulder straps must be equipped with self-locking DoubleBack buckles for quick and easy adjustment.
- 4.4 Harness should have a vertical attachment point that will distribute the load between the waist belt and the leg loops during suspended work.
- 4.5 There should be two lateral attachment points that will transfer the load to the waist belt for comfort when working with feet supported and they must be able to be flipped back against the waist belt when snagging is an issue.
- 4.6 It must have a sternal and a dorsal attachment point for connecting a fall arrest system.
- 4.7 In the event of a fall on the dorsal attachment point, the weight must be taken up on the leg loop, allowing the user to remain suspended longer while awaiting rescue.
- 4.8 Harness should have an attachment point on the waist belt for connecting a restraint lanyard.
- 4.9 It should have a minimum of 5 pre-shaped equipment loops with protective sheathing.
- 4.10 It should have slots for CARITool tool holder and TOOLBAG tool pouch.

#### 5. SPECIFIC REQUIREMENTS FOR THE FALL ARREST KITS

- 4.1 Fall Arrest Harnesses must be CE EN 361, 358 and 813 certified.
- 4.2 Fall Arrest Harnesses must be PETZL make.

#### 6. DELIVERY OF THE EQUIPMENT

The Fall Arrest Kits must be delivered to our Bellville Depot and the delivery cost must be included in the quoted price.
