- **10.** Envelopes must not contain documents relating to any RFP other than that shown on the envelope. All envelopes must reflect the return address of the Respondent on the reverse side.
- **11.** No slips are to be attached to the response documents. Any additional conditions must be embodied in an accompanying letter. Subject only to clause 22 (*Alterations made by the Respondent to Tendered Prices*) of the US7 General Tender Conditions, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

### 12. BROAD-BASED BLACK ECONOMIC EMPOWERMENT ("BBBEE")

TRANSNET fully endorses and supports the South African Government's Broad-Based Black Economic Empowerment Programme and it is strongly of the opinion that all business enterprises have an equal obligation to redress the imbalances of the past. TRANSNET would therefore prefer to do business with business enterprises who share these same values and who are prepared to contribute to meaningful BBBEE initiatives (including and not limited to enterprise development, subcontracting and Joint Ventures) as part of their tender response.

Transnet would accordingly allow a "preference" in accordance with the 10% preference system, as per the Preferential Procurement Policy Framework Act 5 of 2000 (as amended) to companies who provide a BBBEE accreditation Certificate. All procurement and disposal transactions in excess of R30000 will be evaluated accordingly. All transactions below R30000 will as far as possible be earmarked for EME's.

TRANSNET consequently urges Respondents (Large enterprises and QSE's – see below) to have themselves duly accredited by any one of the Accreditation Agencies <u>approved</u> by SANAS (South African National Accreditation System, under the auspices of the DTI).

In terms of Government Gazette No. 32094, Notice No. 354 dated 23 March 2009, as from 1 August 2009, only BBBEE accreditation Certificates issued by SANAS approved verification agencies will be valid.

However accreditation certificates issued before 23 March 2009 and which are still within their one (1) year validity period will still be acceptable, until their expiry date provided that the accreditation was done in accordance with the latest codes (i.e. those promulgated on 9 February 2007).

BBBEE Accreditation Certificates issued after the published date i.e. 23 March 2009, by a Verification Agency not approved by SANAS, will **NOT** be acceptable as from 23 March 2009.

Enterprises will be rated by such Accreditation Agencies based on the following:

- (a) <u>Large Enterprises (i.e. annual turnover >R35 million):</u>

- ➤ EME's should provide documentary proof of annual turnover (i.e. audited financials) plus proof of Black ownership if Black ownership >50% or Black Women ownership >30% (to be renewed annually) from their Auditors / Accounting Officers

In addition to the above, Respondents who wish to enter into a Joint Venture (JV) or subcontract portions of the contract to BBBEE companies must state in their Tenders / Quotations the percentage of the total contract value which would be allocated to such BBBEE companies, should they be successful in being awarded any business. A rating certificate in respect of such BBBEE JV-partners and/or sub-contractors, as well as a breakdown of the distribution of the aforementioned percentage allocation must also be furnished with the tender response to enable Transnet to evaluate / adjudicate on all tenders received on a fair basis.

# **BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS**

#### 1. BACKGROUND

- a) Transnet Freight Rail (TFR) is a business division of Transnet Limited, and it has a broad range of service departments.
- b) The "WORKS" called for in this document are for the supply and install 7 air dryers to earmarked 34-600 Diesel locomotives operating on the Coalline and stationed in Ermelo.
- c) The "WORKS" called for in this document have an impact on the safe operations of trains by TFR. The level of workmanship, the quality and durability of the goods, and adherence to safety rules and regulations is of the utmost importance.
- d) The "WORKS" called for an ECPB Through Cables lay-out and components/equipment similar as the operational ECPB 34-600 Diesel Locomotives.

#### 2. **EXECUTIVE OVERVIEW**

Transnet Operating Divisions currently procure their requirements though a number of service providers. Our objective is to source all activities through a Preferred Supplier(s) capable of supply and install 7 ECPB Through Cables in Ermelo operational area to  $7 \times 34-600$  Diesel Locomotives.

In this spirit of partnership, Transnet and its Supplier(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Transnet to reach higher levels of quality, service and profitability.

### 3. SCOPE OF REQUIREMENTS

- a) This scope requires the supply and fitment of 7x ECPB Through Cables to 7x 34-600 Diesel Locomotives in Ermelo operational area.
- b) Although the attached specification has a more extended scope that this RFP, the entire scope has been advertised in the market under separate RFP numbers, which have been divided into market segments.
- c) Where a brand or part number has been furnished, it by no means is restricted to nor eliminates other brands or part numbers, it is merely to indicate a standard of quality that is required. Where such a brand / part number is quoted, the phrase: "or equal" is to be read in conjunction with the brand / part number. Any equal and equivalent product, that meets the specification in quality and performance, will be considered.
- d) The brand / part number being offered must be inserted in the pricing schedule for each item being tendered. This will assist Transnet in comparing the quality of the product being offered.

#### 4. GENERAL INFORMATION

The service provider(s) shall be fully responsible to Transnet for the acts and omissions of persons directly or indirectly employed by them.

The service provider(s) must provide the identified information requested and comply with the requirements stated in the RFP.
