- Respondents without a valid RFQ document in their possession will not be allowed to attend the briefing session.
- As the site visit will be held in an operational area of Transnet, all people entering the premises must wear safety boots and safety vests and may also be subjected to a substance abuse test. This is a standard operational requirement for TFR, when entering any operational area in order that TFR RME may address the risk of injury. Any person that fails such test will not be permitted to enter the premises and thereby forfeits rights to be allowed access to the briefing session and will subsequently not be permitted to submit a bid for the tender.
