2 Broad-Based Black Economic Empowerment [B-BBE

Transnet fully endorses and supports the Government's Broad-Based Black Economic Empowerment Programme and it would therefore prefer to so business with local business enterprises who share these same values. Transnet will accordingly allow therefore prefer to companies who provide a valid B-BBEE Verification Certificate. All procurement transactions will be evaluated accordingly.

2.1 B-BBEE Scorecard and Rating

As prescribed in televis of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its Regulations, Respondents are to note that the following preference point system is applicable to a bids:

- the 83/20 system for requirements with a Rand value of UP R1 000 000 (all applicable ses included).
- Bidders are to note that if the 80/20 preference point system is stipulated in this RFP and all Bids received are ABOVE R1 000 000.00, the RFP must be cancelled.

The value of this bid is estimated to be Above R1000 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

When Transnet invites prospective suppliers to submit Proposals for its various expenditure programmes, it requires Respondents to have their B-BBEE status verified in compliance with the Codes of Good Practice issued in terms of the Broad Based Black Economic Empowerment Act No. 53 of 2003.

The Department of Trade and Industry recently revised the Codes of Good Practice on 11 October 2013 [Government Gazette No. 36928]. The Revised Codes will replace the Black Economic Empowerment Codes of Good Practice issued on 9 February 2007. The Revised Codes provide for a one year transitional period starting 11 October 2013. During the transitional period, companies may elect to be measured in terms of the Revised Codes or the 2007 version of the Codes. After the first year of the implementation of the Revised Codes, B-BBEE compliance will be measured in

terms of the Revised Codes without any discretion. Companies which are governed by Sectorspecific Codes will be measured in terms of those Sector Codes.

As such, Transnet will accept B-BBEE certificates issued based on the Revised Codes. Transnet will also continue to accept B-BBEE certificates issued in terms of the 2007 version of the Codes provided it was issued before 10 October 2014. Thereafter, Transnet will only accept B-BBEE certificates issued based on the Revised Codes.

Respondents are required to complete Annexure A [the B-BBEE Preference Point Claim Form] and submit it together with proof of their B-BBEE Status as stipulated in the Claim Form in order to obtain preference points for their B-BBEE status.

Note: Failure to submit a valid and original B-BBEE certificate or a certified copy thereof at the Closing Date of this RFQ will result in a score of tero being allocated for B-BBEE.

The commitments made by the successful Respondents will be incorporated as a term of the contract and monitored for compliance.

1. INTRODUCTION

- 1.1 A total of **20** preference points shall be wanted for B-BBEE Status Level of Contribution.
- 1.2 Failure on the part of a Bidder to IV in a d/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System [SANAS] or a Registered Auditor approved by the Independent Regulatory Board of Auditors [IRBA] or an Accounting Officer as contentiated in the Close Corporation Act [CCA] together with the bid will be interpreted to main that preference points for B-BBEE Status Level of Contribution are not claimed.
- 1.3 Transnet receives the right to require of a Bidder, either before a Bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by Transnet.

2. GENERAL DEFINITIONS

- 21 "all applicable taxes" include value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 "B-BBEE status of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **"Bid"** means a written offer in a prescribed or stipulated form in response to an invitation by Transnet for the provision of goods, works or services;
- 2.5 **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 [Act No. 53 of 2003];
- 2.6 "comparative price" means the price after the factors of a non-firm price and all unconditional

- discounts that can utilised have been taken into consideration;
- 2.7 "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract;
- 2.8 "contract" means the agreement that results from the acceptance of a bid by Transnet;
- 2.9 **"EME"** means any enterprise with an annual total revenue of R5 [five] million or less as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with an annual total revenue of R10 [ten] million or less as per the Revised Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928;
- 2.10 "firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or about on of customs and excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of the supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 "functionality" means the measurement according to redetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacit, an ability of a bidder;
- 2.12 "non-firm prices" means all prices other than "firm" prices;
- 2.13 "person" includes reference to a juristic person;
- 2.14 "QSE" means any enterprise with an annual total revenue between R5 [five] million and R35 [thirty five] million as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with an annual total revenue of between R10 [ten] million and R50 [fifty] million as per the Revise's Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928
- 2.15 **(rand value**" means the total estimated value of a contract in South African currency, calculated at botime of bid invitations, and includes all applicable taxes and excise duties;
- "subcontract" means the primary contractor's assigning or leasing or making out work to, or employing another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.17 **"total revenue"** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Empowerment Act and promulgated in the Government Gazette on 9 February 2007;
- 2.18 **"trust"** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.19 **"trustee"** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

1. DEFINITIONS

Where the following words or phrases are used in this Agreement, such words or phrases shall have the meaning assigned thereto in this clause, except where the context clearly requires otherwise:

- 1.1 Bid shall mean a Respondent's tendered response / proposal to a Transnet RFP or RFQ;
- 1.2. Bid Document(s) shall mean a reference to a Request for Proposal or Request for Quotation;
- 1.3 Day shall mean any day other than a Saturday, Sunday or public holiday;
- 1.4 Respondent(s) shall mean a respondent/bidder to a Bid Document;
- 1.5 RFP shall mean Request for Proposal;
- 1.6 RFQ shall mean Request for Quotation;
- 1.7 RFX shall mean RFP or RFQ, as the case may be;
- 1.8 Services shall mean the services required by Transnet as specified in its Bid Document;
- 1.9 Service Provider shall mean the successful Respondent;
- **1.10 Tax Invoice** shall mean the document as required by Section 20 of the Value-Added Tax Act, 89 of 1991, as may be amended from time to thre;
- 1.11 Transnet shall mean Transnet SOC L d, a Sate Owned Company; and
- **1.12 VAT** shall mean Value-Added Tax in this of the Value-Added Tax Act, 89 of 1991, as may be amended from time to time.

2. GENERAL

All Bid Documents and subsequent contracts and orders shall be subject to the following general conditions as laid down by Transpet and are to be strictly adhered to by any Respondent to this RFX.

3. SUBMISSION OF BILL OCUMENTS

A Bid which shall hereinafter include reference to an RFP or RFQ, shall be submitted to Transnet no later than the closing date and time specified in accordance with the directions issued in the Bid Documents. Late Bids will not be considered.

Bids shall be delivered in a sealed envelope in accordance with the instructions indicated in the Bid Documents with the Bid number and subject marked on the front of the envelope.

The Respondent's return address must be stated on the reverse side of the sealed envelope.

4.USE OF BID FORMS

Where special forms are issued by Transnet for the submission of Bids, Respondents are required to submit their Bids by completion of the appropriate sections on such official forms and not in other forms or documents bearing their own terms and conditions of contract. Non-compliance with this condition may result in the rejection of a Bid.

Respondents must note that the original Bid forms must be completed for submission and not a reprocessed copy thereof.

Only if insufficient space has been allocated for a particular response may a Respondent submit additional information under separate cover using its company's letterhead. This must be duly cross-referenced in the RFX.

5. BID FEES

A non-refundable fee may be charged for Bid Documents, depending on the administrative cost of preparing and issuing such Bid Documents.

Only Respondents that have paid the Bid fee and provided proof of payment when submitting their Bid will be considered.

6. VALIDITY PERIOD

Respondents must hold their Bid valid for acceptance by Transnet at any time within the requested validity period after the closing date of the RFX.

Respondents may be requested to extend their validity period for a specified additional period. In such instances, Respondents will not be allowed to change any aspect on their Bid, unless they are able to demonstrate that the proposed change(s) is as a direct and unevoidable consequence of Transnet's extension of the validity period.

7. SITE VISIT / BRIEFING SESSION

Respondents may be requested to attend (i) a site visit where it is considered necessary to view the site prior to the preparation of Bids, or (ii) an RECLER g session when Transnet deems it necessary to provide Respondents with additional information relevant to the compilation of their Bids. When such visits or sessions are indicated as compulsor in the bid Document, Respondents are obliged to attend these meetings as failure to do so will result in their disqualification.

8. CLARIFICATION BEFORE THE CLOSING DATE

Should clarification be required on any aspect of the RFX before the closing date, the Respondent must direct such queries to be contact person identified in the Bid Document.

9. COMMUNICATION AFTER THE CLOSING DATE

After the closure date of a Bid [i.e. during the evaluation period] the Respondent may only communicate with the Secretary of the relevant Acquisition Council.

10. UNAU HORISED COMMUNICATION ABOUT BIDS

Where Bids are submitted to the Secretary of an Acquisition Council, Respondents may at any time communicate with the Secretary on any matter relating to its Bid but, in the absence of written authority from the Secretary, no communication on a question affecting the subject of a Bid shall take place between Respondents or other potential service providers or any member of the Acquisition Council or official of Transnet during the period between the closing date for the receipt of the Bid and the date of the notification of the successful Respondent(s). A Bid, in respect of which any such unauthorised communication has occurred, could be disqualified.

11. RETURNABLE DOCUMENTS

All returnable documents listed in the RFX Documents must be submitted with Respondent's Bid. Failure to submit mandatory returnable schedules / documents will result in disqualification. Failure to submit other schedules / documents may result in disqualification.

12. DEFAULTS BY RESPONDENTS

If the Respondent, after it has been notified of the acceptance of its Bid fails to:

enter into a formal contract when called upon to do so within such period as Transnet may specify; or accept an order in terms of the Bid;

furnish satisfactory security when called upon to do so for the fulfilment of the contract; or comply with any condition imposed by Transnet,

Transnet may, in any such case, without prejudice to any other legal remedy which it may have, proceed to accept any other Bid or, if it is necessary to do so, call for Idds afresh, and may recover from the defaulting Respondent any additional expense incurred by Transpet in calling for new offers or in accepting a less favourable offer.

If any Respondent, who has submitted a Bid and/or concluded a consect with Transnet [hereinafter referred to as the **Service Provider**], or in the capacity of agant or subcontractor who has been associated with such Bid or contract:

Has withdrawn such Bid after the advertised date and hour for the receipt of Bids; or

has, after having been notified of the accepta ce of its Bid, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the Bid Documents; or

has carried out any contract respiting from such Bid in an unsatisfactory manner or has breached any condition of such contract; or

has offered, promised or given a bribe in relation to the obtaining or the execution of such contract;

Has acted in a randulent or improper manner or in bad faith towards Transnet or any government department accowards any public body, company or person; or

Has made any misleading or incorrect statement either

in the affidavit or certificate referred to in clause 0 [Notice to Unsuccessful Respondents]; or any other document submitted as part of its Bid submission

Has been found guilty by a court of law, tribunal or other administrative body of a serious breach of any law, during the preceding 5 [five] years;

then a Bid from any such Respondent shall be disqualified and the person, enterprise or company [including any directors] shall, subject to clause 0 below, be disqualified from bidding for any Transnet business through its "blacklisting" process.

15. ALTERATIONS MADE BY THE RESPONDENT TO BIJ PRICES

All alterations made by the Respondent to its Bid price(s) prior to the submission of its Bid Documents must be done by deleting the incorrect figures and words against the items concerned. All such alterations must be initialled by the person who signs the Bid Documents. The Service Provided hay be required to submit periodical progress reports with regard to the delivery of the Services.

Emergen v Jemands as and when required

If due to unforeseen circumstances, the rendering of the Services covered by the Bid are required at sort notice for immediate delivery, the Service Provider will be given first right of refusal for such business. If it is unable to meet the desired critical delivery period, Transnet reserves the right to purchase such services as may be required to meet the emergency outside the contract if immediate delivery can be offered from any other source. The "Total or Partial Failure to Perform the Scope of Services" section in the Terms and Conditions of Contract will not be applicable in these circumstances.

28. SPECIFICATIONS AND COPYRIGHT

Specifications

The Respondent should note that, unless notified to the contrary by Transnet or a designated official by means of an official amendment to the Bid Documents, it is required to tender for the Services strictly in accordance with the specifications supplied by Transnet.

Copyright

Copyright in plans, drawings, diagrams, specifications and documents compiled by the Service Provider for the purpose of contract work shall be governed by the *Intellectual Property Rights* section in the Terms and Conditions of Contract.

29.BIDS BY OR ON BEHALF OF FOREIGN RESPONDENTS

ANNEXTURE B SECTION 9: SUPPLIER CODE OF CONDUCT

Suppliers Code of Conduct

Transnet aims to achieve the best value for money when buying or selling goods and obtaining services. This, however, must be done in an open and fair manner that supports and drives a competitive economy. Underpinning our process are several acts and policies that any supplier dealing with Transnet must understand and support.

These are:

- »> Section 217 of the Constitution the first offers of Public PSCM (Procurement and Supply Whate Management): fair, equitable, transparent competitive and cost effective:
- >> The Public Finance Management Act (PFMA);

This code of conduct has been compiled to formally apprise Transner's European of Transner's expectations regarding behaviour and conduct of its Suppliers.

Nohibition of Bribes, Kickbacks, Unlawful Payments, and Other Corrupt Practices

Transnet is in the process of transforming itself into a selfsustaining State Owned Enterprise, actively competing in the logistics industry. As such, our transformation is focused on adopting a performance culture and to adopt behaviours that will enable this transformation.

Transmetwill not participate in corrupt practices. Therefore, it expects its suppliers to act in a similar manner.

Transnet and its employees will follow the laws of this country and keep accurate business records that reflect actual transactions with, and payments to, our suppliers.





Employees must not accept or request money or anything of value, directly or indirectly, from suppliers.

Employees may not recieve anything that is calculated to:

- Illegally influence their judgement or conduct or to influence the outcome of a sourcing activity;
- Win or retain business or to influence are act or decision of any person involved in sourcing decisions; gain an improper advantage
- There may be times when a supplier is confronted with fraudulent or corrupt behaviour of Transnet exployees. We expect our suppliers to use our "Un-offs Anonymous" Hotline to report these acts - 0800 003 056.

Transport is from constitted to free and competitive extension.

- >> Suppliers are expected to comply with all applicable laws and regulations regarding resistance competition and antitrust practices
- >> Yransnet does not engage non-value adding agents or representatives solely for the purpose of increasing BBBEE spend (fronting).

Transpet's relationship with suppliers requires us to clearly define requirements, to exchange information and shere mutual benefits.

Senerally, suppliers have their own business standards and regulations. Although Transnet cannot control the actions of our suppliers, we will not tolerate any idegal activities.


