### 2 Broad-Based Black Economic Empoyerment [8-BBEE]

### 1.0 Description of work

- 1.1 The works consists of the following:
  - 1) Site measurements of the openings for the new security gates.
  - 2) Site measurements of the perimeter for all sites.
  - 3) Supply of material, fabrication and transportation of new palisade fencing to site.
  - 4) Dismantle the existing security fencing and transport to Transnet Freight Rail depots.
  - 5) Installation of new palisade fence at the various sites.

### 3.0 Services

- 3.1 The Contractor shall have access to the electricity supply from Transnet Freight Rail, but since this supply cannot be guaranteed, he must make provision for a standby power supply.
- 3.2 The Contractor shall be responsible for the establishment and deestablishment of site.
- 3.3 Fixed assets such as fencing shall be removed or demolished after completion of the works.
- 3.4 Housing of the Contractor's staff inside Transnet Freight Rail's property and servitude shall not be permitted.

- 3.5 The Contractor shall supply toilet facilities for use by his workmen.
- 3.6 The Contractor shall also provide for his own water as this service is not guaranteed on the work sites.

### 4.0 Management of works

### 4.1 Programming, methods and procedures

- 4.1.1 The work shall be completed according to the programme to be prepared and submitted by the Contractor.
- 4.1.2 At the completion of the works the Contractor shall clear the site of any left over material to the satisfaction of the Supervisor. The site shall be left in the same or better condition than it was before.
- 4.1.3 The Contractor shall comply with the requirements of Transnut specification BBD8210 for "Works on, over, under or adjacent to railway lines and near high voltage equipment".
- 4.1.4 Hours of work will be from 08H00 to 15H30 Mondays o Fridays.
- 4.1.5 While at the construction site, the movements of the Contractor's staff shall be restricted within the designated work area to avoid contact with high voltage electrical equipment.
- 4.1.6 It shall be the responsibility of the Contractor to care for the works, plant and material while under construction until a keover by Transnet Freight Rail.
- 4.1.7 The old fence and posts stall be transported to the nearest Transnet Freight Rail depot for disposal.

### 4.2 Quality plans and con rol

- 4.2.1 The Contractor shall tubulit with his tender the proposed Quality Control Plan and Procedures for approval. This plan shall indicate how the necessary quality assistance and control will be carried out in order to comply with the requirements of the specifications.
- 4.2.2 The plan shall consist of check lists and measurements sheets to be concolled by the Contractor in order to substantiate that the complete work conforms to the specifications with respect to material, quantity, methods and the requirements.
- 4.2.3 The completed check lists shall be handed over to Transnet Freight Rail after the completion of every site.
- 4.2.4 Transnet Freight Rail shall, in conjunction with the Contractor, inspect and approve the premises, processes and products of Suppliers before any items are ordered from them.

### 4.3 Communication

Scope of Work

- 4.3.1 The Contractor shall supply and have available on site at all times three A4 size triplicate carbon copy books.
- 4.3.2 In one book site instructions shall be recorded. Only Transnet Freight Rail's contract Supervisor or his delegated representatives shall have the authority to issue site instructions to the Contractor.
- 4.3.3 The second book will be used as the risk register.
- 4.3.4 The third book will be used as a site diary. Site diaries will be handed to the Transnet Freight Rail's contract Supervisor at the monthly progress meetings.

- 4.3.5 The original sheet of each set of three pages will be removed from the books and retained by the Project Manager. The Contractor may remove the second sheet but the third sheet shall be retained in the book on site until completion of the works when the books shall be handed to the Project Manager.
- 4.3.6 Any instruction which results in a change in scope or has cost implications shall only be carried out once an approved quotation for a compensation event is issued by the Project Manager.
- 4.3.7 Site activities for the day as well as information regarding personnel on site, equipment, weather, delays, hours worked and details of visitors on site shall be entered in the site diary on a daily basis.
- 4.3.8 Requests for meetings or site inspections shall be in the form of e-mail.

### 4.4 Site personnel

- 4.4.1 The Contractor shall provide an Organogram of his key rersonnel on site, including all relevant contact details within two weeks it me the contract start date.
- 4.4.2 The Contractor shall also keep on file copies of identity documents of all his personnel on site (including casual labour)

### 4.5 Meetings

4.5.1 Contract / Progress meetings:

- 4.5.3 The minutes of these meetings are to be filed. Minutes are to be kept by the Project manager and will be issued as soon as possible.

### 4.6 Payments

- 4.6.1 On or after the assessment date, the Project Manager / Supervisor and the Contractor will together assess the progress on each item in the Bill of Quantities and items shall be listed in quantities and where this is not possible, quantities for the month shall be expressed in percentages.
- 4.6.2 The Contractor shall then submit a VAT invoice and attach his Progress Certificate for payment by Transnet Freight Rail.

4.6.3 Transnet Freight Rail will only pay for installed material. No payment will be made for material delivered to site.

### 4.7 Permits

4.7.1 The Supervisor shall issue the Contractor with Access Certificates permitting entry to the various sites.

### 4.8 Proof of compliance with the law

4.8.1 The Contractor's approved safety plan and fall protection plan shall be used as proof of compliance with Act 85 of 1993.

### 4.9 Health and safety requirements and procedures

- 4.9.1 The Contractor shall comply with the requirements of the Training and Safety specification E4E (August 2006) by compiling a safety Man, doing the necessary appointments, declarations and notifications, as per the E4E guidelines in the document.
- 4.9.2 The attention of the Contractor is drawn to "life" electrical overhead wires or underground cables existing in the area covered by this contract and the danger of coming in contact with such wires or plercing underground electrical cables, during excavations.
- 4.9.3 The Contractor shall make all his be sonnel aware of the danger of "live" electrical wires and cables as will as induced stray voltages from AC electrification into cables and equipment before commencing with the work.
- 4.9.4 The Contractor and each number of his personnel who may be required to enter high voltage substations for the purpose of performing work in terms of this contract must:
  - Observe Transpet Freight Rail's Electrical Safety Instructions regarding the entry of rersonnel into all substations, control rooms and equipment sites accommodating equipment on which work must be preformed. Failure to comply with these requirements will render the Contractor liable for lired or indirect costs resulting from such negligence.
  - Figure that they are in possession / have completed the proper dovements authorising them to enter high voltage substations of Transnet reight Rail.
- 9. Whenever the Contractor or any member of his personnel enters a high voltage substation yard belonging to Transnet Freight Rail, he must enter his details and the reason for the visit in the substation logbook and sign it.
- 4.9.6 When the Contractor or any member of his personnel is about to leave the substation on completion of his duty he must complete the entry in the substation logbook.
- 4.9.7 Special care shall be exercised when welding or flame cutting operations occur and tenderers are required to provide suitable fire fighting equipment at close hand as prescribed by the Occupational Health and Safety Act, Act 85 of 1993.
- 4.9.8 The Contractor shall provide the necessary number of suitable first aid outfits, one set in the camp and one set at each working team. He shall maintain these outfits fully equipped at all times.
- 4.9.9 The Contractor's staff shall always wear personal protective clothing when they are on site.

- 4.9.10 The Contractor shall report all accidents in writing to the Transnet Freight Rail's contract Supervisor. Any accident resulting in the death of or injury to any person on the Works shall be reported within 24 hours of its occurrence, and any other accident shall be reported within 48 hours of its occurrence.
- 4.9.11 At the end of the contract, the Contractor shall submit to Transnet Freight Rail the project safety file for safekeeping.
- 4.9.12 Before commencing work, the Contractor will be required to undergo and pass safety training to be offered by Transnet Freight Rail. The cost of training will be carried by the Contractor.

Appendix 1 Schedule of Quantities

### 1.0 SCOPE

1.1 This specification covers Transnet Freight Rail requirements for the design, supply and installation of galvanized Steel Palisade Fencing at Dejagersdrift and Besters substations countrywide.

### 2.0 DESIGN AND CONSTRUCTION

- 2.1 POSTS
- 2.1.1 The main posts for the substations shall be constructed of I.P.E. section 100 x 55 x 5mm with a maximum spacing between posts, centre to centre, of not more than 2500mm.
- 2.1.2 The posts shall have a minimum height of 3000mm.
- 2.1.3 All posts shall be hot dip galvanized to SANS121.
- 2.1.4 Where existing posts are re-used, a main post shall be planted in a foundation midway between the existing posts.
- 2.1.5 The height of the planted posts shall be the same height as the pracent pales.
- 2.1.6 The corner posts shall have a 12mm (diameter) held on the centre of the section-300mm above ground level. This is for earthing purioses
- 2.1.7 None of the posts may be joined on site by welding in order to comply with the specified height.
- 2.2 PALES
- 2.2.1 The minimum height of the pales above good shall be 2400mm.
- 2.2.2 The pales for substations shall be constructed of 40 x 40 x 5mm angle iron sections.
- 2.2.3 The top of the pales shall have the spearhead shape.
- 2.2.4 No vertical pales may be pined by welding in order to comply with the specified height.
- 2.3 PANELS
- 2.3.1 The panels shall be constructed of pales specified in sections 2.2 and 2.4 of this specification and shall be hot dip galvanized to SANS121 after fabrication.
- 2.3.2 All pales shall be completely welded, on both sides to the horizontal rails. All welding flux shall be removed prior to galvanizing. Cold galvanizing shall be used to touch up if remedial welding is cont on site.
- 2.3.3 The first amount gap distance between the pales shall not exceed 120mm.
- 2.3.4 The maximum length of the panels shall not exceed 2500mm.
- 2.3.5 The maximum distance from the top rail to the top of the pale shall not exceed 600mm and from the bottom rail to the bottom of the pale shall not exceed 400mm.
- 2.4 TOP AND BOTTOM HORIZONTAL RAILS
- 2.4.1 Horizontal rails for substations shall be 40 x 40 x 5mm angle iron sections.
- 2.5 GATEPOSTS AND GATES
- 2.5.1 GENERAL
- 2.5.1.1 All the entrance gateposts for substations shall be constructed of 100x 55 x 5 (mm) section.
- 2.5.1.2 The frame of the substation gate shall be 80 x 60 x 5mm.
- 2.5.1.3 The in-fill for the substation gate frame shall be 40 x 40 x 5mm angle iron sections spaced 110mm apart.
- 2.5.1.4 Anti-tamper facilities shall be provided for each gate's locking mechanism.
- 2.5.1.5 A design for the anti tamper facility shall be submitted with the tender for evaluation.

- 2.5.1.6 All the gates shall have the spearheaded pales protruding at the top by 150mm.
- 2.5.1.7 All welding on the gates and panels shall be full (No tack welding).
- 2.5.2 MAIN ENTRANCE
- 2.5.2.1 The gate shall be a sliding type with a 5000mm opening. The height of the gate shall match that of the adjacent fence.
- 2.5.2.2 The sliding gate's locking mechanism for the substations shall be such that two people using different padlocks shall be able to gain access to the substation individually (i.e. Transnet Freight Rail and Eskom personnel).
- 2.5.2.3 The strength of the locking mechanism shall be the same as the rest of the fence.
- 2.5.2.4 A design for the anti tamper facility shall be submitted with the tender for evaluation.
- 2.5.2.5 All gates and gateposts shall be hot dip galvanized to SANS124
- 2.5.2.6 The gates shall be fitted with anti-lifting devices to prevent lifting off the rail.
- 2.5.3 AUXILIARY ENTRANCES
- 2.5.3.1 The auxiliary gates shall be swing gates with 150 mm, 3000mm and 5000mm opening. The height of the pedestrian gate shall match the aciacer fence.
- 2.5.3.2 The gate with the 1500mm opening shall be a single leaf fitted with 2 heavy duty hinges. One at the top and the other at the bottom
- 2.5.3.3 The gates with 3000mm and 5000mm or nings shall be double leaf fitted with 4 heavy duty hinges on either side.
- 2.5.3.4 The locking mechanism for the subscripn's 1.5m auxiliary gates shall be such that two people using different padlocks shall be able to gain access to the substation individually (i.e. Transnet Freight Rail and Eskom personnel).
- 2.6 FOUNDATIONS
- 2.6.1 Concrete foundations for the gate (main and auxiliary entrances) posts shall not be less than 300 x 300 x 500 (lees) mm.
- 2.6.2 The concrete base of all entrance gates shall have a width of 500mm and a foundation depth of 250mm.
- 2.6.2.1 The concine base at the main entrance gates shall be suitable for passage of vehicles.
- 2.6.2.2 The countrie base at the pedestrian entrance shall be suitable for passage of staff and tank drawn maintenance equipment.
- 2.6.2. The foundations for the gates shall be raised by 50mm at the centre and be lowered towards the edges to allow for smooth entry of vehicles.
- 2.6.3 The foundations mentioned for all posts shall protrude at least 100mm above ground level and be designed to prevent water from standing.
- 2.6.4 The wheel size for the gates shall be series 80 and a round bar shall be installed on the base of the gate to run the wheel.
- 2.7 BUND WALL
- 2.7.1 The concrete bund wall (base at the bottom of the fence) shall have the following dimensions:
  - Width 200mm.
  - Foundation depth (Measured from ground level) 200mm.
  - Protruding from ground level 100mm.

### 2.8 CONCRETE

- 2.8.1 The minimum strength of all concrete used, (all foundations and the bund wall) shall not be less than 15Mpa after 28 days.
- 2.8.2 The contractor shall arrange for sampling and testing of all concrete used and shall submit full records to the Supervisor. The method of sampling used shall comply with specification \$420.
- 2.8.3 If ready mix concrete is used, the contractor shall submit certificates confirming the strength of the concrete to the Supervisor.
- 2.8.4 The addition of water to a concrete mix reduces the strength of that concrete mix significantly, therefore no water may be added to the concrete mix once a sample has been taken.
- 2.8.5 Only mechanically mixed concrete is acceptable. Hand mixed concrete shall not be acceptable.

### 3.0 INSTALLATION

- 3.1 Upon demolition of existing fences, the working team shall create new fence on the same day in order not to leave the site exposed.
- 3.2 In order to achieve this, the Contractor can demolist the innce in small sections per day.
- 3.3 A concrete base (Bund Wall) shall be provided at the pottom of the fence as well as the gates, if not existing on site.
- 3.3.1 The Bund wall shall only be installed where it is missing or is not in good condition. If only a small section of the Bund Wall is damaged, ben only that section must be replaced.
- 3.4 Where a new bund wall is to be installed, the palisade panel shall be buried a minimum of 50mm into the bund wall.
- 3.5 Where the existing security tence is connected to other security fences of other parties and the fence has to be cut, the fence of the other party must be reconnected to the newly installed fence by the Contractor.
- 3.6 When the existing fince is demolished, the poles shall be cut at the base. The new fence shall be installed, ust asize the old Bund Wall.
- 3.7 The Contractor shall provide for the transportation of the demolished fence to a site to be specified by the supot. The cost of the transportation shall be included under Preliminary and General.

- 4.1 Where special forms are issued by Transnet for the submission of Bids, Respondents are required to submit their Bids by completion of the appropriate sections on such official forms and not on office stationery bearing their own terms and conditions of contract; non-compliance with this conditions may result in the rejection of a Bid.
- 4.2 Respondents must note that the original Bid forms must be completed for submission and not a reprocessed facsimile thereof. Only if insufficient space has been allocated to a particular response

may a Respondent submit additional information under separate cover using the Company's letterhead and duly cross-referenced in the RFX.

### 5 RAISING OF A CHARGE FOR PLANS, SPECIFICATIONS AND BID FORMS

- 5.1 A non-refundable charge may be raised for Bid Documents, depending on the administrative cost of preparing and issuing the Bid Document.
- 5.2 If any of the drawings or specifications referred to in Bid Documents are the official publications of recognised standardising bodies, copies of such drawings and specifications shall be acquired by Respondents at their own expense.

### **6 DEFAULTS BY RESPONDENTS**

- 6.1 If the Respondent, after it has been notified of the acceptance on its Bid fails to:
  - a) enter into a formal contract when called upon to do so in terms of clause 14 [Contract Documents], within such period as Transnel may specify; or
  - b) accept an order in terms of the Bid;
  - c) when called upon to do so, furnish russfactory security of the fulfilment of the contract in terms of clause 15 [Securities]

Transnet may, in any such calle, without prejudice to any other legal remedy which it may have, proceed to accept any other Bid or lifet is necessary to do so, call for Bids afresh, and may recover from the defaulting Respondent any additional expense incurred by it in calling for new offers or in accepting a higher offer.

- 6.2 If any Responding who has submitted a Bid and/or concluded a contract with Transnet [hereinafter referred to as **the Carvice Provider**], or in the capacity of agent or subcontractor who has been associated with such Bid or contract:
  - has withdrawn such Bid after the advertised date and hour for the receipt of Bids; or
  - as, after having been notified of the acceptance of its Bid, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the Bid Documents; or
  - c) has carried out any contract resulting from such Bid in an unsatisfactory manner or has breached any condition of such contract; or
  - d) has offered, promised or given a bribe in relation to the obtaining or the execution of such contract; or
  - e) has acted in a fraudulent or improper manner or in bad faith towards Transnet or any government department or towards any public body, company or person; or
  - f) has made any incorrect statement in the affidavit or certificate referred to in clause 12 [Formal Notification Regarding Name of Successful Respondent] and is unable to prove to the satisfaction of Transnet that
    - (i) it made the statement in good faith honestly believing it to be correct; and

- (ii) before making such statement, it took all reasonable steps to satisfy itself of its correctness; or
- g) caused Transnet damage, or to incur costs in order to meet the Service Provider's requirements which could not be recovered from the Service Provider;

then a Bid from any such Respondent shall be disqualified and the person, enterprise or company [including any directors] shall, subject to clause 6.3 below, be disqualified from bidding for any Transnet business through its "blacklisting" process.

- 6.3 Any person or enterprise or company against whom a decision has been given under the provisions of clauses 6.2b), 6.2d) or 6.2e) above, may make representations to the Charle Operating Officer of Transnet Group, whose decision shall be final.
- Any disqualification [Blacklisting] imposed upon any person of other pile or company, may also apply to any other enterprise under the same or different names of disqualified persons or enterprise or company [or associates thereof] and shall for avoidance of doubt also be applied to any agent or employee of the person or enterprise or company of incerned.

### 7 CURRENCY

Prices or fees must be quoted in the currency of the Republic of South Africa [ZAR] in respect of local Services. Prices or fees in any other currency per be rejected by Transnet save where such price is quoted by a foreign Respondent.

### 8 EXCHANGE AND REMITTANCE

The Respondent should note that where the whole or a portion of the contract or order value is to be remitted overseas Gran set shall, if requested to do so by the Service Provider, effect payment overseas directly to the foreign principal or manufacturer of such percentage of the contract or order value as may be stipulated by the Respondent in its Bid Documents and any variation in the amount to be so paid, which may arise as a result of fluctuations in the rate of exchange involved, will be for the account of the Service Provide.

- 8. The Respondent who desires to avail itself of the aforementioned facility must at the time of bidding furnish the information called for in the clause "Exchange and Remittance" of the Bid Documents and also furnish full details of the principals or service providers to whom payment is to be made.
- 8.2 The Service Provider shall at its own cost obtain forward exchange cover on foreign currency to protect itself against any currency rate fluctuation risks for the duration of any resulting contract or order. Transnet will NOT accept any fluctuations in the rate of exchange at the time when payments are made.

Transnet will not recognise any claim for adjustment of the order and/or contract price under clause 8.2 above, if the increase in price arises after the date on which the Services were to be completed, as set out in the order and/or contract, or any subsequent agreement between the parties.

### 9 ACCEPTANCE OF BID

9.1 Transnet does not bind itself to accept the lowest or any Bid.

- 9.2 Transnet reserves the right to accept any Bid in whole or in part.
- 9.3 Upon the acceptance of a Bid by Transnet, the parties shall be bound by these General Bid Conditions and the Standard Terms and Conditions of Contract [Form ST&C – Services] and any schedule of "Special Conditions" or otherwise which form part of the Bid Documents.
- 9.4 Where the Respondent has been informed by Transnet per facsimile message or email of the acceptance of its Bid, the acknowledgement of the receipt transmitted shall be regarded as proof of delivery to the Respondent.

### 10 LAW GOVERNING CONTRACT

The law of the Republic of South Africa shall govern the contract created by the acceptance of a Bid. The domicilium citandi et executandi shall be a place in the Republic C. South Africa to be specified by the Respondent in its Bid at which all legal documents may be so ved unit the Respondent who shall agree to submit to the jurisdiction of the courts of the Republic of South Africa. A foreign Respondent shall, therefore, state in its Bid the name of its authorised representative in the Republic of South Africa who is empowered to sign any contract which may be entered into in the event of its Bid being accepted and to act on its behalf in all matters relating to the contract.

### 11 IDENTIFICATION

If the Respondent is a company, the full names of the directors shall be stated in the Bid. If the Respondent is a close corporation, the full names of the members shall be stated in the Bid. If the Respondent is a partnership or an individual tracking under a trade name, the full names of the partners or of such individual, as the case may be, shall be varietied.

### 12 FORMAL NOTIFICATION REGARDING NAME OF SUCCESSFUL RESPONDENT

In the case as Bid submitted to the Secretary of an Acquisition Council, unsuccessful Respondents will be formally notified of the names of successful Respondent(s) as soon as possible after the closing date for recognish to Pa in question.

### 13 ULAU HORISED COMMUNICATION ABOUT BIDS

Where Bids are submitted to the Secretary of an Acquisition Council, Respondents may at any time communicate with the Secretary on any matter relating to its Bid but, in the absence of written authority from the Secretary, no communication on a question affecting the subject of a Bid shall take place between Respondents or other potential suppliers or any member of the Acquisition Council or official of Transnet during the period between the closing date for the receipt of the Bid and the date of the notification of the successful Respondent(s). A Bid, in respect of which any such unauthorised communication has occurred, may be disqualified.

### 14 CONTRACT DOCUMENTS

14.1 The contract documents will comprise these General Bid Conditions and the Standard Terms and Conditions of Contract [Form ST&C – Services] and any schedule of "Special Conditions" or otherwise which form part of the Bid Documents.

14.2 These contract documents will constitute the contract between the parties upon receipt by the Respondent of Transnet's letter of acceptance / intent, subject to all additional amendments and/or special conditions thereto as agreed to by the parties.

### 15 SECURITIES

- 15.1 The successful Respondent, when called upon to do so, shall provide security to the satisfaction of Transnet for the due fulfilment of a contract or order. Such security shall be in the form of a deed of suretyship [Deed of Suretyship] furnished by an approved bank, building society, insurance or quarantee corporation carrying on business in South Africa.
- 15.2 The security may be applied in whole or part at the discretion of incursive to make good any loss or damage which Transnet may incur in consequence of a breach of the contract or any part thereof.
- 15.3 Such security, if required, shall be an amount which will be so, unted in the Bid Documents.
- 15.4 For the purpose of clause 15.1 above, Transnet will supply a Deed of Suretyship form to the successful Respondent for completion and no guarantee in any other form will be accepted. A copy of such form will be supplied to Respondent on request. For this purpose a Deed of Suretyship form will be provided which shall be completed in returned to Transnet or a designated official by the successful Respondent within 30 [thirty] days from the date of the letter of acceptance. No payment will be made until the form, duly complete, is delivered to Transnet. Failure to return the Deed of Suretyship within the prescribe time shall, save where prior extension has been granted, entitles Transnet without notice to the Service Provider to cancel the contract with immediate effect.
- Additional costs incurred by transnet necessitated by reason of default on the part of the Service Provider in relation to the conditions of this clause 15 will be for the account of the Service Provider.

### 16 PRICES SUBJECT TO CONFIRMATION

- 16.1 A Fid with a ces which are subject to confirmation will not be considered.
- 16.2 Bio. where firm prices are quoted for the duration of any resulting order and or contract will receive recedence over prices which are subject to adjustment.

### \*\*\* LETION OF SERVICES EXCLUDED FROM BID

The Respondent must delete Services for which it has not tendered or for which the price or fee has been included elsewhere in its Bid.

### 18 ALTERATIONS MADE BY THE RESPONDENT TO BID PRICES

All alterations made by the Respondent to its Bid price(s) prior to the submission of its Bid Documents must be done by deleting the incorrect figures and words where required and by inserting the correct figures and words against the items/Services concerned. All such alterations must be initialled by the person who signs the Bid Documents. Failure to observe this requirement may result in the particular item(s) or Services concerned being excluded in the matter of the award of the business.

### 19 VALUE-ADDED TAX

- 19.1 In respect of local Services, i.e. Services to be provided by a South African company, the prices or fees quoted by the Respondent are to be exclusive of VAT which must be shown separately at the standard rate on the Service Provider's Tax Invoice.
- 19.2 In respect of Services to be provided by a foreign principal:
  - a) the invoicing by the Service Provider on behalf of its foreign principal represents a service rendered by the principal;
  - b) the Service Provider's Tax Invoice(s) for the local portion only file, the "commission" for the services rendered locally] must show the VAT separately

### 20 TERMS AND CONDITIONS OF BID

- 20.1 The Service Provider shall adhere to the Standard Terms and Conditions of Contract as set out in Form ST&C Services, a copy of which is issued with the Rid Documents, together with any schedule of "Special Conditions" or otherwise which form pan of the Bid Documents.
- 20.2 Should the Respondent find any conditions to acceptable, it should indicate which conditions are unacceptable and offer alternatives by the submission on a company letterhead. Any such submission shall be subject to review by Transnet's Legal Counsel who shall determine whether the proposed alternative(s) are acceptable or otherwise, as the case may be.

### 21 IMPORTANT NOTICE TO RESPONDENTS REGARDING PAYMENT

### 21.1 Method of Payment

- a) The attention of the Respondent is directed to clause 10 [Invoices and Payment] of Form STCC Services, which sets out the conditions of payment on which Bid price(s) shall be base!
- However, in addition to the aforegoing the Respondent is invited to submit offers based on a dernative methods of payment and/or financing proposals.
- The Respondent is required to give full particulars of the terms that will be applicable to its alternative offer(s) and the financial merits thereof will be evaluated and taken into consideration when the Bid is adjudicated.
- d) The Respondent must, therefore, in the first instance, tender strictly in accordance with clause 21.1a) above. Failure to comply with clause 21.1a) above may preclude a Bid from further consideration.

NOTE: The successful Respondent [the **Service Provider**] shall, where applicable, be required to furnish a guarantee covering any advance payments.

### 21.2 Conditional Discount

Respondents offering prices which are subject to a conditional discount applicable for payment within a specific period are to note that the conditional period will be calculated as from the date of receipt by Transnet of the Service Provider's month-end statement reflecting the relevant Tax Invoice(s) for payment purposes, provided the conditions of the order or contract have been fulfilled and the Tax

Invoice is correct in all respects as referred to in the contract or order. Incomplete and/or incorrect Tax Invoices shall be returned and the conditional period will be recalculated from the date of receipt of the correct documentation.

### 22 PLANS, DRAWINGS, DIAGRAMS, SPECIFICATIONS AND DOCUMEN

Copyright in plans, drawings, diagrams, specifications and documents compiled by the Service Provider for the purpose of contract work shall be governed by the terms and conditions detailed in clause 12 of Form ST&T - Services (Intellectual Property Rights).

### 23 VISITS TO FOREIGN COUNTRIES

- 23.1 Respondents must furnish details in a covering letter if it is considered to cessary that employees of Transnet should carry out inspection and/or review any operational services at the premises of the preferred Respondent or its subcontractors overseas for the purpose of a product demonstration and/or final acceptance or for any other reason.
- 23.2 If the Respondent considers overseas visits to be a cessary it must provide the following information in a covering letter in respect of each proposed isit:
  - a) countries and places to be visi ed;
  - b) number of employees an disciplines involved;
  - c) number of man-days involved; and
  - d) motivation for the vist
- 23.3 Transnet will make a transpersents with regard to booking of air journeys, hotel reservations, transport to anti-from airports, places of inspection or demonstration, etc. and all expenses will be for the account or Transper.
- 23.4 Before a visit is undertaken, such as envisage in this clause 23, Transnet and the Respondent will acree in writing on the number of employees of Transnet that should undertake the visit and the number of man-days involved in the visit.

# 24 BUS BY OR ON BEHALF OF FOREIGN RESPONDENTS

- Bids submitted by foreign principals may be forwarded direct by the principals to the Secretary of the Acquisition Council or to a designated official of Transnet according to whichever officer is specified in the Bid Documents, or may be so forwarded on the principal's behalf by its South African representative or agent provided that written proof is submitted that such representative or agent has been duly authorised to act in that capacity by the principal. Failure to submit such authorisation by the representative or agent shall disqualify the Bid.
- 24.2 When legally authorised to prepare and submit Bids on behalf of their principals not domiciled in the Republic of South Africa, representatives or agents must compile the Bids in the names of such principals and sign them on behalf of the latter.
- 24.3 South African representatives or agents of a successful foreign Respondent must when so required enter into a formal contract in the name of their principals and must sign such contract on behalf of

the latter. In every such case a legal Power of Attorney from their principals must be furnished to Transnet by the South African representative or agents authorising them to enter into and sign such contract.

- a) Such Power of Attorney must comply with Government Notice No. 1160 of 27 June 1930 [and any amendments thereto] "Rules of the Supreme Court of South Africa for the authentication of documents executed outside the Republic for use within the Republic."
- b) The Power of Attorney must be signed by the principal under the same atle as used in the Bid Documents.
- c) On arrival within the Republic of South Africa this Power of Attorney is to be completed in terms of Section 8(2) of the Stamp Duties Act No. 77 of 1948, a any amendment thereof.
- d) If a Power of Attorney held by the South African representative or agent includes matters of a general nature besides provision for the entering into an 1 signing of a contract with Transnet, a certified copy thereof should be furnished.
- e) The Power of Attorney must authorise the South African representative or agent to choose the domicilium citandi et executandi a pro ided for in clause 26 [Addresses for Notices] of the Standard Conditions of Contract, resp. T&C Services.
- 24.4 If payment is to be made in South Africa, the foreign Supplier [i.e. the principal, or its South African agent or representative], must notify Transnet in writing whether, for payment by electronic funds transfer [EFT]:
  - a) funds are to be 'causi gred to the credit of the foreign Supplier's account at a bank in South Africa, in which a so the name and branch of such bank shall be furnished; or
  - b) fund are a be transferred to the credit of its South African agent or representative, in which case the lame and branch of such bank shall be furnished.
- 24.5 The attents of the Respondent is directed to clause 15 above [Securities] regarding the provision of security for the fulfilment of contracts and orders and the manner and form in which such security is to be furnished.

### 1 INTRODUCTION

When an Agreement is entered into between Transnet SOC Ltd [Transnet] and the appointed supplier of Services to Transnet [the Service Provider], these Standard Terms and Conditions of Contract, the technical specifications for the Services, the General Bid Conditions, a Schedule of Requirements or Work Order including such special conditions as may be applicable, and any terms in the associated Bid Documents, exclusively govern the provision of Services by the Service Provider to Transnet.

### 2 DEFINITIONS

Where the following words or phrases are used in the Agreement, such words or phrases shall have the meaning assigned thereto in this clause, except where the context clearly requires otherwise:

- 2.1 AFSA means the Arbitration Foundation of South Africa;
- 2.2 Agreement means the Agreement and its associated chedules and/or annexures and/or appendices, including the Work Order(s), specifications for the Services and such special conditions as shall apply to the Agreement, together with the General Tender Conditions and any additional provisions in the associated bid as amounts tendered by the Service Provider [as agreed in writing between the Parties], which offectively and exclusively govern the provision of Services by the Service Provider to Transnes.
- 2.3 Background Intellectual Property means all Intellectual Property introduced and required by either Party to give effect to their obligations under the Agreement owned in whole or in part by or licensed to either Party or their affiliates prior to the Commencement Date or developed after the Commencement pate otherwise pursuant to the Agreement;
- 2.4 **Business D y(s)** has no Mondays to Fridays between 07:30 and 16:00, excluding public holidays as proclaimed in South Africa;
- 2.5 **Communcement Date** means [\*], notwithstanding the signature date of the Agreement;
- 2.6 **Confidential Information** means any information or other data, whether in written, oral, graphs or in any other form such as in documents, papers, memoranda, correspondence, tebooks, reports, drawings, diagrams, discs, articles, samples, test results, prototypes, designs, plans, formulae, patents, or inventor's certificates, which a Party discloses or provides to the other Party [intentionally or unintentionally, or as a result of one Party permitting the representative of the other Party to visit any of its premises], or which otherwise becomes known to a Party, and which is not in the public domain and includes, without limiting the generality of the term:
  - a) information relating to methods of operation, data and plans of the disclosing Party;
  - b) the contents of the Agreement;
  - private and personal details of employees or clients of the disclosing Party or any other person where an onus rests on the disclosing Party to maintain the confidentiality of such information;
  - any information disclosed by either Party and which is clearly marked as being confidential or secret;
  - e) information relating to the strategic objectives and planning of the disclosing Party relating to its existing and planned future business activities;

- f) information relating to the past, present and future research and development of the disclosing Party;
- g) information relating to the business activities, business relationships, products, services, customers, clients and Subcontractors of the disclosing Party where an onus rests on the disclosing Party to maintain the confidentiality of such information;
- h) information contained in the software and associated material and documentation belonging to the disclosing Party;
- technical and scientific information, Know-How and trade secrets of a disclosing Party including inventions, applications and processes;
- j) Copyright works;
- k) commercial, financial and marketing information;
- data concerning architecture, demonstrations, tools and a uniques, processes, machinery and equipment of the disclosing Party;
- m) plans, designs, concepts, drawings, functions and technical requirements and specifications of the disclosing Party,
- n) information concerning faults of defects in goods, equipment, hardware or software or the incidence of such faults or refect; and
- information concerning the charges, Fees and / or costs of the disclosing Party or its authorised Subcontractors, or their methods, practices or service performance levels actually achieved:
- 2.7 Copyright means the right in expressions, procedures, methods of operations or mathematical concepts, computer program codes, compilations of data or other material, literary works, musical works, a fistic works, sound recordings, broadcasts, program carrying signals, published editions, photographic works, or cinematographic works of the copyright owner to do or to authorise the oling of certain acts specified in respect of the different categories of works;
- 2.8 **refault** means any breach of the obligations of either Party [including but not limited to fundamental breach or breach of a fundamental term] or any Default, act, omission, negligence or statement of either Party, its employees, agents or Subcontractors in connection with or in relation to the subject of the Agreement and in respect of which such Party is liable to the other;
- 2.9 Deliverable(s) means any and all works of authorship, products and materials developed, written, prepared, assembled, integrated, modified or provided by the Service Provider in relation to the Services;
- 2.10 Designs mean registered Designs and/or Design applications and will include the monopoly right granted for the protection of an independently created industrial design including designs dictated essentially by technical or functional considerations as well as topographies of integrated circuits and integrated circuits;
- 2.11 Fee(s) shall mean the agreed Fees for the Services to be purchased from the Service Provider by Transnet, as detailed in the Work Order(s), issued in accordance with the Agreement, as amended by mutual agreement between the Parties and in accordance with the provisions of the Agreement from time to time;

- 2.12 **Foreground Intellectual Property** means all Intellectual Property developed by either Party pursuant to the Agreement;
- 2.13 Intellectual Property means Patents, Designs, Know-How, Copyright and Trade Marks and all rights having equivalent or similar effect which may exist anywhere in the world and includes all future additions and improvements to the Intellectual Property;
- 2.14 **Know-How** means all Confidential Information of whatever nature relating to the Intellectual Property and its exploitation as well as all other Confidential Information generally relating to Transnet's field of technology, including technical information, processing or manufacturing techniques, Designs, specifications, formulae, systems, processes, information concerning materials and marketing and business information in general;
- 2.15 Materials means the Deliverables, the Service Provider Materials and the Third Party Materials;
- 2.16 **Parties** mean the Parties to the Agreement together with bein subsidiaries, divisions, business units, successors-in-title and their assigns;
- 2.17 Party means either one of these Parties;
- 2.18 Patents mean registered Patents and Patent applications, once the latter have proceeded to grant, and includes a right granted for any invariance, products or processes in all fields of technology;
- 2.19 **Permitted Purpose** means any activity of process to be undertaken or supervised by Personnel or employees of one Party during the erm of the Agreement, for which purpose authorised disclosure of the other Party's Confidential Information or Intellectual Property is a prerequisite in order to enable such activity of precess to be accomplished;
- 2.20 Personnel means by partner, employee, agent, consultant, independent associate or supplier, Subcontractor and the starf of such Subcontractor, or other authorised representative of either Party;
- 2.21 **Purch se Order(s)** means official orders issued by an operating division of Transnet to the Service revolver for the provision of Services;
- 2.22 **Cervice(s)** means [•], the Service(s) provided to Transnet by the Service Provider, pursuant to the Work Order(s) in terms of the Agreement;
- 2.23 Service Level Agreement or SLA means the processes, deliverables, key performance indicators and performance standards relating to the Services to be provided by the Service Provider;
- 2.24 Subcontract means any contract or agreement or proposed contract or agreement between the Service Provider and any third party whereby that third party agrees to provide to the Service Provider the Services or any part thereof;
- 2.25 **Subcontractor** means the third party with whom the Service Provider enters into a Subcontract;
- 2.26 Service Provider Materials means all works of authorship, products and materials [including, but not limited to, data, diagrams, charts, reports, specifications, studies, inventions, software, software development tools, methodologies, ideas, methods, processes, concepts and techniques] owned by, or licensed to, the Service Provider prior to the Commencement Date or independently developed by the Service Provider outside the scope of the Agreement at no expense to Transnet, and used by the Service Provider in the performance of the Services;

- 2.27 Tax Invoice means the document as required by Section 20 of the Value-Added Tax Act, 89 of 1991, as may be amended from time to time;
- 2.28 Third Party Material means software, software development tools, methodologies, ideas, methods, processes, concepts and techniques owned by, or licensed to a third party and used by the Service Provider in the performance of the Services;
- 2.29 **Trade Marks** mean registered Trade Marks and trade mark applications and includes any sign or logo, or combination of signs and/or logos capable of distinguishing the goods or services of one undertaking from those of another undertaking;
- 2.30 **VAT** means Value-Added Tax chargeable in terms of the Value-Added Tax Act, 89 of 1991, as may be amended from time to time; and
- 2.31 Work Order(s) means a detailed scope of work for a Service required by Transnet, including timeframes, Deliverable, Fees and costs for the supply of the Service to Transnet, which may be appended to the Agreement from time to time.

### 3 INTERPRETATION

- 3.1 Clause headings in the Agreement are included or ease of reference only and do not form part of the Agreement for the purposes of interpretation or for any other purpose. No provision shall be construed against or interpreted to the disadvantage of either Party hereto by reason of such Party having or being deemed to have structured or drafted such provision.
- 3.2 Any term, word, acronym of phrase used in the Agreement, other than those defined under the clause heading "Definitions" shall be given its plain English meaning, and those terms, words, acronyms, and phrases send in the Agreement will be interpreted in accordance with the generally accepted meanings as orded thereto.
- 3.3 A reference to the ingular incorporates a reference to the plural and vice versa.
- 3.4 A reference to fatural persons incorporates a reference to legal persons and vice versa.
- 3.5 A reference to a particular gender incorporates a reference to the other gender.

### 4 NATURE AND SCOPE

- The Agreement is an agreement under the terms and conditions of which the Service Provider will arrange for the provision to Transnet of the Services which meet the requirements of Transnet, the delivery of which Services is controlled by means of Purchase Orders to be issued by Transnet and executed by the Service Provider, in accordance with the Agreement.
- 4.2 Such Purchase Orders shall be agreed between the Parties from time to time, subject to the terms of the relevant Work Order(s).
- 4.3 Each properly executed Purchase Order forms an inseparable part of the Agreement as if it were fully incorporated into the body of the Agreement.
- During the period of the Agreement, both Parties can make written suggestions for amendments to the Work Order(s), in accordance with procedures set out in clause 28 [Amendment and Change Control] below. A Party will advise the other Party within 14 [fourteen] Business Days, or such other period as mutually agreed, whether the amendment is acceptable.
- 4.5 Insofar as any term, provision or condition in the Work Order(s) conflicts with a like term, provision or condition in the Agreement and/or a Purchase Order, or where the Agreement is

- silent on the matter, the term, provision or condition in this Master Agreement shall prevail, unless such term or provision or condition in this Master Agreement has been specifically revoked or amended by mutual written agreement between the Parties.
- 4.6 Time will be of the essence and the Service Provider will perform its obligations under the Agreement in accordance with the timeframe(s) [if any] set out in the relevant schedule, save that the Service Provider will not be liable under this clause if it is unable to meet such obligation within the time required as a direct result of any act or omission by Transnet and it has used its best endeavours to advise Transnet of such act or omission. In the event of such delay, any time deadlines detailed in the relevant schedule shall be extended by a period equal to the period of that delay.

### 5 AUTHORITY OF PARTIES

- 5.1 Nothing in the Agreement will constitute or be deemed to constitute a partnership between the Parties, or constitute or be deemed to constitute the Parties as agents or employees of one another for any purpose or in any form whatsoever.
- 5.2 Neither Party shall be entitled to, or have the power or authority to enter into an agreement in the name of the other; or give any warranty, it presentation or undertaking on the other's behalf; or create any liability against the other or and the other's credit in any way or for any purpose whatsoever.

#### 6 WARRANTIES

- 6.1 The Service Provider warrants to Transnet that:
  - it has diff apprecity and authority to enter into and to perform the Agreement and that the
     Agreement is executed by a duly authorised representatives of the Service Provider;
  - b) It will ducharge its obligations under the Agreement and any annexure, appendix or shedule hereto with all due skill, care and diligence;
  - it will be solely responsible for the payment of remuneration and associated benefits, if any, of its Personnel and for withholding and remitting income tax for its Personnel in conformance with any applicable laws and regulations;
  - d) it will procure licences for Transnet in respect of all Third Party Material detailed in the Work Order(s), and will procure the right for Transnet to take such copies [in whole or in part] of such Third Party Materials as it may reasonably require for the purposes of backup for archiving and disaster recovery; and
  - e) the use or possession by Transnet of any Materials will not subject Transnet to any claim for infringement of any Intellectual Property Rights of any third party.
- 6.2 The Service Provider warrants that it will perform its obligations under the Agreement in accordance with the Service Levels as defined in the relevant schedule. Transnet may at its discretion audit compliance with the Service Levels, provided that any such audit is carried out with reasonable prior notice and in a reasonable way so as not to have an adverse effect on the performance of the Services. Without prejudice to clause 6.3 below, in the event that the Service Provider fails to meet the Service Levels, Transnet may claim appropriate service credits or invoke a retention of Fees as detailed in the relevant schedule and/or Work Order.

- 6.3 The Service Provider warrants that for a period of 90 [ninety] days from Acceptance of the Deliverables they will, if properly used, conform in all material respects with the requirements set out in the relevant schedule. The Service Provider will at its expense remedy any such non-conformance as soon as possible but in any event within 30 [thirty] days of notification by Transnet. In the event that the Service Provider fails or is unable to remedy such non-conformance within such time-scale, Transnet will be entitled to employ a third party to do so in place of the Service Provider and any excess charges or costs incurred by Transnet as a result shall be paid by the Service Provider.
- 6.4 The Service Provider will remedy any defect within 30 [thirty] days of being notified of that defect by Transnet in writing.
- 6.5 The Service Provider will not be liable to remedy any problet, arising from or caused by any modification made by Transnet to the Deliverables, or any part then of without the prior approval of the Service Provider.
- 6.6 The Service Provider shall advise Transnet of the effects of any steps proposed by Transnet pursuant to clause 6.5 above, including but not limited to any cost implications or any disruption or delay in the performance of the Services. The Parties agree that any changes to the Services, including the charges for the Services exam timetables for delivery of the Services, will be agreed in accordance with the change control procedure, as set out in clause 28 [Amendment and Change Control].
- 6.7 The Service Provider warrants that:
  - it has, using the most up-to-date software available, tested for [and deleted] all commonly known viruses in the Materials and for all viruses known by the Service Provider at the date of the relevant. Vork Order; and
  - b) at the time of delivery to Transnet, the Materials do not contain any trojan horse, worm, bgic armb, time bomb, back door, trap door, keys or other harmful components.
  - The State Provider agrees that, in the event that a virus is found, it will at its own expense use s best endeavours to assist Transnet in reducing the effect of the virus and, particularly in the event that a virus causes loss of operational efficiency or loss of data, to assist Transnet to the same extent to mitigate such losses and to restore Transnet to its original operating efficiency.
- The Service Provider undertakes to comply with South Africa's general privacy protection in terms of the Bill of Rights [Section 14] in connection with the Agreement and shall procure that its Personnel shall observe the provisions of Section 14 [as applicable] or any amendments and reenactments thereof and any regulations made pursuant thereto.
- 6.9 The Service Provider warrants that it has taken all reasonable precautions to ensure that, in the event of a disaster, the impact of such disaster on the ability of the Service Provider to comply with its obligations under the Agreement will be reduced to the greatest extent possible, and that the Service Provider shall ensure that it has appropriate, tested and documented recovery arrangements in place.
- 6.10 In compliance with the National Railway Safety Regulator Act, 16 of 2002, the Service Provider shall ensure that the Services, to be supplied to Transnet under the terms and conditions of the Agreement, comply fully with the specifications as set forth in Schedule 1 hereto, and shall thereby adhere [as applicable] to railway safety requirements and/or regulations. Permission for

the engagement of a Subcontractor by the Service Provider [as applicable] shall be subject to a review of the capability of the proposed Subcontractor to comply with the specified railway safety requirements and/or regulations. The Service Provider and/or its Subcontractor shall grant Transnet access, during the term of the Agreement, to review any safety-related activities, including the coordination of such activities across all parts of its organisation.

### 7 TRANSNET'S OBLIGATIONS

- 7.1 Transnet undertakes to promptly comply with any reasonable request by the Service Provider for information, including information concerning Transnet's operations and occuvities, that relates to the Services as may be necessary for the Service Provider to perform the Services, but for no other purpose. However, Transnet's compliance with any request for information is subject to any internal security rules and requirements and subject to the observance by the Service Provider of its confidentiality obligations under the Agreement.
- 7.2 The Service Provider shall give Transnet reasonable notice of any information it requires in accordance with clause 7.1 above.
- 7.3 Subject to clause 13 [Service Provider's Per onnel], Transnet agrees to provide the Service Provider or its Personnel such access to and use on its facilities as is necessary to allow the Service Provider to perform its obligations and the Agreement.

# 8 GENERAL OBLIGATIONS OF THE SERVICE PROVIDER

- 8.1 The Service Provider shall:
  - a) respond protectly to all complaints and enquiries from Transnet;
  - b) inform fram set immediately of any dispute or complaint arising in relation to the provision of the Services;
  - c) conduct its business in a professional manner that will reflect positively upon the Service Provider and the Service Provider's Services;
  - keep full records clearly indicating all transactions concluded by the Service Provider relating to the performance of the Services and keep such records for at least 5 [five] years from the date of each such transaction;
  - obtain, and at all times maintain in full force and effect, any and all licences, permits and the like required under applicable laws for the provision of the Services and the conduct of the business and activities of the Service Provider;
  - observe and ensure compliance with all requirements and obligations as set out in the labour and related legislation of South Africa, including the Occupational Health and Safety Act, 85 of 1993;
  - g) comply with all applicable environmental legislation and regulations, and demonstrate sound environmental policies, management and performance; and
  - h) ensure the validity of all renewable certifications, including but not limited to its Tax Clearance Certificate and B-BBEE Accreditation Certificate, for the duration of the Agreement. Should the Service Provider fail to present Transnet with such renewals as they become due, Transnet shall be entitled, in addition to any other rights and remedies that it may have in terms of the Agreement, to terminate the Agreement forthwith without any

liability and without prejudice to any claims which Transnet may have for damages against the Service Provider.

- 8.2 The Service Provider acknowledges and agrees that it shall at all times:
  - a) render the Services and perform all its duties with honesty and integrity;
  - b) communicate openly and honestly with Transnet and demonstrate a commitment to performing the Services timeously, efficiently and to the required standards;
  - c) endeavour to provide the highest possible standards of service and professionalism, with a reasonable degree of care and diligence;
  - d) use its best endeavours and make every diligent effort to meet agreed deadlines;
  - e) treat its own Personnel, as well as all Transnet's officers, exployees, agents and consultants, with fairness and courtesy and respect for cein upon rights;
  - f) practice and promote its own internal policies aimed at prohibiting and preventing unfair discrimination [as further referred to in clause 22 Equality and Diversity];
  - g) treat all enquiries from Transnet in connection when the Services with courtesy and respond to all enquiries promptly and efficient. Where the Service Provider is unable to comply with the provisions of this clause the Service Provider will advise Transnet of the delay and the reasons therefor and will keep Transnet informed of progress made regarding the enquiry;
  - h) when requested by Transnet provide clear and accurate information regarding the Service Provider's own policies and procedures, excluding Know-How and other Confidential Information, except where a non-disclosure undertaking has been entered into between the Prices;
  - i) put allow a conflict of interest to develop between its own interests [or the interests of any of its other customers] and the interests of Transnet;
  - accept or offer, nor allow, induce or promote the acceptance or offering of any gratuity, enticement, incentive or gift that could reasonably be regarded as bribery or an attempt to otherwise exert undue influence over the recipient;
  - not mislead Transnet or its officers, employees and stakeholders, whether by act or omission;
  - not otherwise act in an unethical manner or do anything which could reasonably be expected to damage or tarnish Transnet's reputation or business image; and
  - m) immediately report to Transnet any unethical, fraudulent or otherwise unlawful conduct of which it becomes aware in connection with Transnet or the provision of Services.

### 9 FEES AND EXPENSES

- 9.1 In consideration of the provision of the Services, Transnet will pay to the Service Provider the Fees detailed in the relevant schedule or Work Order.
- 9.2 Transnet will not be invoiced for materials used in the provision of the Services save for those materials [if any] set out in the Work Order and accepted by Transnet or in any relevant Work Order [which will be invoiced to Transnet at cost].

- 9.3 Unless otherwise agreed in a schedule or Work Order, Transnet will reimburse to the Service Provider all reasonable and proper expenses incurred directly and solely in connection with the provision of the Services, provided that all such expenses:
  - a) are agreed by Transnet in advance;
  - b) are incurred in accordance with Transnet's standard travel and expenses policies;
  - c) are passed on to Transnet at cost with no administration fee; and
  - will only be reimbursed if supported by relevant receipts.
- 9.4 All Tax Invoices relating to Fees, out of pocket expenses and, if applicable, travel and accommodation costs, will provide the detail for each of the Personnel carrying out the Services and incurring the expenses, and the Tax Invoice will, where appropriate, include VAT as a separate item.

### 10 INVOICING AND PAYMENT

- 10.1 Transnet shall pay the Service Provider the amounts stipul ted in the relevant schedule or Work Order, subject to the terms and conditions of the Agreement.
- Transnet shall pay such amounts to the service Provider, upon receipt of a correct and undisputed Tax Invoice together with the supporting rocumentation as specified in the Work Order appended hereto, once the undisputed Tax Invoices, or such portion of the Tax Invoices which are undisputed become due and payabate to the Service Provider for the provision of the Services, in terms of clause 10.4 below.
- 10.3 All Fees and other times payable under the Agreement are exclusive of VAT, which will be payable at the applicable atte
- 10.4 Unless otherwise provided for in the Work Order(s) appended to the Agreement, Tax Invoices shall be submitted together with a month-end statement. Payment against such month-end statement shall be made by Transnet within 30 [thirty] days after date of receipt by Transnet of the statement together with all undisputed Tax Invoices and supporting documentation.
- Where the payment of any Tax Invoice, or any part thereof which is not in dispute, is not made in accordance with this clause 10, the Service Provider shall be entitled to charge interest on the outstanding amount, at The Standard Bank of South Africa's prime rate of interest in force, for the period from the due date of payment until the outstanding amount is paid.

### 11 FEE ADJUSTMENTS

- 11.1 Fees for Services rendered in terms of the Agreement shall be subject to review as indicated in the Work Order(s) annexed hereto from time to time.
- 11.2 No less than 2 [two] months prior to any proposed Fee adjustment, the Parties shall commence negotiations for Fees for the next period or as otherwise indicated and appended hereto.
- 11.3 Should Transnet and the Service Provider fail to reach an agreement on Fees for the successive period, either Party shall be entitled to submit this matter to dispute resolution in accordance with clause 25 of this Master Agreement [Dispute Resolution].

### 12 INTELLECTUAL PROPERTY RIGHTS

#### 12.1 Title to Confidential Information

- Transnet will retain all right, title and interest in and to its Confidential Information and Background Intellectual Property and the Service Provider acknowledges that it has no claim of any nature in and to the Confidential Information and Background Intellectual Property that is proprietary to Transnet. For the avoidance of doubt, all the Service Provider's Background Intellectual Property shall remain vested in the Service Provider.
- b) Transnet shall grant to the Service Provider an irrevocable, royally free, non-exclusive licence to use Transnet's Background Intellectual Property only for the Permitted Purpose. This license shall not permit the Service Provider to sub-license to other parties.
- c) The Service Provider shall grant to Transnet an irrevocable, royalty free, non-exclusive licence to use the Service Provider's Background of self-equal Property for the Permitted Purpose. This licence shall not permit Transnet to sob-exense to other parties.
- d) The Service Provider shall grant Transnet alicess to the Service Provider's Background Intellectual Property on terms which shall be *bona fide* negotiated between the Parties for the purpose of commercially explaining the Foreground Intellectual Property, to the extent that such access is required.

### 12.2 Title to Intellectual Property

- a) All right, title and interest in and to Foreground Intellectual Property prepared, conceived or developed by the Sanie Provider, its researchers, agents and employees shall vest in Transnet and the Service Provider acknowledges that it has no claim of any nature in and to the Foreground intellectual Property. The Service Provider shall not at any time during or after the termination or cancellation of the Agreement dispute the validity or enerceability of such Foreground Intellectual Property, or cause to be done any act or anything contesting or in any way impairing or tending to impair any part of that right, title and interest to any of the Foreground Intellectual Property and shall not counsel or assist any person to do so.
- Transnet shall be entitled to seek protection in respect of the Foreground Intellectual Property anywhere in the world as it shall decide in its own absolute discretion and the Service Provider shall reasonably assist Transnet in attaining and maintaining protection of the Foreground Intellectual Property.
- c) Where the Foreground Intellectual Property was created by the Service Provider or its researchers, agents and employees and where Transnet elects not to exercise its option to seek protection or decides to discontinue the financial support of the prosecution or maintenance of any such protection, Transnet shall notify the Service Provider who shall have the right of first refusal to file or continue prosecution or maintain any such applications and to maintain any protection issuing on the Foreground Intellectual Property.
- d) No consideration shall be paid by Transnet to the Service Provider for the assignment of any Foreground Intellectual Property from the Service Provider to Transnet, over and above the sums payable in terms of the Agreement. The Service Provider undertakes to

- sign all documents and do all things as may be necessary to effect, record and perfect the assignment of the Foreground Intellectual Property to Transnet.
- e) Subject to anything contrary contained in the Agreement and/or the prior written consent of Transnet [which consent shall not be unreasonably be withheld or delayed], the Service Provider shall under no circumstances be entitled as of right, or to claim the right, to use Transnet's Background Intellectual Property and/or Foreground Intellectual Property.

### 12.3 Title to Improvements

Any improvements, developments, adaptations and/or modifications to the foreground Intellectual Property, and any and all new inventions or discoveries, based on ordersulting from the use of Transnet's Background Intellectual Property and/or Confidential Internation shall be exclusively owned by Transnet. The Service Provider shall disclose promptly to Transnet all such improvements, developments, adaptations and/or modifications, inventions or discoveries. The Service Provider hereby undertakes to sign all documents and do all things as may be necessary to effect, record and perfect the assignment of such improvements, developments, adaptations and/or modifications, inventions or discoveries to the snet and the Service Provider shall reasonably assist Transnet in attaining, may taking or documenting ownership and/or protection of the improved Foreground Intellectual Property.

### 12.4 Unauthorised Use of Confidential 1. formation

The Service Provider shall not authorise any party to act on or use in any way any Confidential Information belonging to transnet whether or not such party is aware of such Confidential Information, and shall promptly notify Transnet of the information if it becomes aware of any party so acting, and shall provide Transnet the information with such assistance as Transnet reasonably requires a Transnet's cost and expense, to prevent such third party from so acting.

# 12.5 Unauth trist Use of Intellectual Property

- a) The Service Provider agrees to notify Transnet in writing of any conflicting uses of, and applications of registrations of Patents, Designs and Trade Marks or any act of infringement, unfair competition or passing off involving the Intellectual Property of Transnet of which the Service Provider acquires knowledge and Transnet shall have the right, as its own option, to proceed against any party infringing its Intellectual Property.
- b) It shall be within the sole and absolute discretion of Transnet to determine what steps shall be taken against the infringer and the Service Provider shall co-operate fully with Transnet, at Transnet's cost, in whatever measure including legal action to bring any infringement of illegal use to an end.
- c) The Service Provider shall cooperate to provide Transnet promptly with all relevant ascertainable facts.
- d) If proceedings are commenced by Transnet alone, Transnet shall be responsible for all expenses but shall be entitled to all damages or other award arising out of such proceedings. If proceedings are commenced by both Parties, both Parties will be responsible for the expenses and both Parties shall be entitled to damages or other award arising out of proceedings.

### 13 SERVICE PROVIDER'S PERSONNEL

- 13.1 The Service Provider's Personnel shall be regarded at all times as employees, agents or Subcontractors of the Service Provider and no relationship of employer and employee shall arise between Transnet and any Service Provider Personnel under any circumstances regardless of the degree of supervision that may be exercised over the Personnel by Transnet.
- 13.2 The Service Provider warrants that all its Personnel will be entitled to work in South Africa or any other country in which the Services are to be performed.
- 13.3 The Service Provider will ensure that its Personnel comply with all reasonable requirements made known to the Service Provider by Transnet concerning conduct at any Transnet premises or any other premises upon which the Services are to be performed [including aut not limited to security regulations, policy standards and codes of practice and health and safety requirements]. The Service Provider will ensure that such Personnel at all times act in allowful and proper manner in accordance with these requirements.
- 13.4 Transnet reserves the right to refuse to admit or to remove from any premises occupied by or on behalf of it, any Service Provider Personnel whose admission or presence would, in the reasonable opinion of Transnet, be undesirable or who represents a threat to confidentiality or security or whose presence would be in breach of any rules and regulations governing Transnet's Personnel, provided that Transnet notifies the Service Provider of any such refusal [with reasons why]. The reasonable exclusion of any such individual from such premises shall not relieve the Service Provider from the performance of its obligations under the Agreement.
- 13.5 The Service Provider agrees to use all reasonable endeavours to ensure the continuity of its Personnel assigned to personn the Services. If any re-assignment by the Service Provider of those Personnel is necessar, or if Transnet advises that any such Personnel assigned are in any respect unsatisfactory, including where any such Personnel are, or are expected to be or have been absent for a syperiod, then the Service Provider will promptly supply a replacement of equivalent calibra and experience, and any such replacement shall be approved by Transnet prior to commencing provision of the Services, such approval not to be unreasonably withheld or delayed.

# 1/ L. MITATION OF LIABILITY

- 14.1 Neither Party excludes or limits liability to the other Party for:
  - a) death or personal injury due to negligence; or
  - b) fraud.
- 14.2 The Service Provider shall indemnify and keep Transnet indemnified from and against liability for damage to any Transnet property [whether tangible or intangible] or any other loss, costs or damage suffered by Transnet to the extent that it results from any act of or omission by the Service Provider or its Personnel in connection with the Agreement. The Service Provider's liability arising out of this clause 14.2 shall be limited to a maximum amount payable in respect of any one occurrence or a series of related occurrences in a single calendar year, such amount to be agreed in writing by the Parties.
- 14.3 Subject always to clauses 14.1 and 14.2 above, the liability of either the Service Provider or Transnet under or in connection with the Agreement, whether for negligence, misrepresentation, breach of contract or otherwise, for direct loss or damage arising out of each Default or series of

- related Defaults shall not exceed 100% [one hundred per cent] of the Fees paid under the schedule or Work Order to which the Default(s) relates.
- 14.4 Subject to clause 14.1 above, and except as provided in clauses 14.2 and 14.3 above, in no event shall either Party be liable to the other for indirect or consequential loss or damage or including indirect or consequential loss of profits, business, revenue, goodwill or anticipated savings of an indirect nature or loss or damage incurred by the other Party as a result of third party claims.
- 14.5 If for any reason the exclusion of liability in clause 14.4 above is void or unenforceable, either Party's total liability for all loss or damage under the Agreement shall be as provided in clause 14.3 above.
- 14.6 Nothing in this clause 14 shall be taken as limiting the liability of the Service Provider in respect of clause 12 [Intellectual Property Rights] or clause 16 [Confidentialty].

### 15 INSURANCES

- 15.1 Without limiting the liability of the Service Provide Lunder the Agreement, the Service Provider shall take out insurance in respect of all risks for which it is prudent for the Service Provider to insure against, including any liability it may have as a result of its activities under the Agreement for theft, destruction, death or injury to any person and damage to property. The level of insurance will be kept under review as transnet, on an annual basis, to ensure its adequacy, provided that any variation to the level of such insurance shall be entirely at the discretion of the Service Provider.
- 15.2 The Service Provider shall arrange insurance with reputable insurers and will produce to Transnet evidence of the exhibition of the policies on an annual basis within 30 [thirty] days after date of policy renewals.

### 16 CONFIDENTIALTY

- 16.1 In Parties hereby undertake the following, with regard to Confidential Information:
  - not to divulge or disclose to any person whomsoever in any form or manner whatsoever, either directly or indirectly, any Confidential Information of the other, without the prior written consent of such other Party, other than when called upon to do so in accordance with a statute, or by a court having jurisdiction, or by any other duly authorised and empowered authority or official, in which event the Party concerned shall do what is reasonably possible to inform the other of such a demand and each shall assist the other in seeking appropriate relief or the instituting of a defensive action to protect the Confidential Information concerned;
  - b) not to use, exploit, permit the use of, directly or indirectly, or in any other manner whatsoever apply the Confidential Information, disclosed to it as a result of the Agreement, for any purpose whatsoever other than for the purpose for which it is disclosed or otherwise than in strict compliance with the provisions in the Agreement;
  - c) not to make any notes, sketches, drawings, photographs or copies of any kind of any part of the disclosed Confidential Information, without the prior written consent of such other Party, except when reasonably necessary for the purpose of the Agreement, in which case such copies shall be regarded as Confidential Information;

- d) not to de-compile, disassemble or reverse engineer any composition, compilation, concept application, item, component de-compilation, including software or hardware disclosed and shall not analyse any sample provided by Transnet, or otherwise determine the composition or structure or cause to permit these tasks to be carried out except in the performance of its obligations pursuant to the Agreement;
- e) not to exercise less care to safeguard Transnet Confidential Information than the Party exercises in safeguarding its own competitive, sensitive or Confidential Information;
- f) Confidential Information disclosed by either Party to the other or by either Party to any other party used by such Party in the performance of the Agreement, shall be dealt with as "restricted" or shall be dealt with according to any other appropriate level of confidentiality relevant to the nature of the information concerned, agreed between the Parties concerned and stipulated in writing for such information in such cases:
- g) the Parties shall not make or permit to be made by any other person subject to their control, any public statements or issue press release or disclose Confidential Information with regard to any matter related to the Agreement, unless written authorisation to do so has first been obtained from the Party and disclosing such information;
- h) each Party shall be entitled to disclore such aspects of Confidential Information as may be relevant to one or more technically qualified employees or consultants of the Party who are required in the course of their duties to receive the Confidential Information for the Permitted Purpose playided that the employee or consultant concerned has a legitimate interest therein, and then only to the extent necessary for the Permitted Purpose, and is informed by the Party of the confidential nature of the Confidential Information and the obligations of the confidentiality to which such disclosure is subject and the Party shall a sure such employees or consultants honour such obligations;
- i) ach tarty shall notify the other Party of the name of each person or entity to whom any Confidential Information has been disclosed as soon as practicable after such disclosure;
  - each Party shall ensure that any person or entity to which it discloses Confidential Information shall observe and perform all of the covenants the Party has accepted in the Agreement as if such person or entity has signed the Agreement. The Party disclosing the Confidential Information shall be responsible for any breach of the provisions of the Agreement by the person or entity; and

- 16.2 The duties and obligations with regard to Confidential Information in this clause 16 shall not apply where:
  - a Party can demonstrate that such information is already in the public domain or becomes available to the public through no breach of the Agreement by that Party, or its Personnel;

### 17 TOTAL OR PARTIAL FAILURE TO PERFORM THE SCOPE OF SERVICES

  - a) a voluntary arrangement or composition or reconstruction of its debts;
  - b) its winding-up or dissolution;

  - any similar action, application or proceeding in any jurisdiction to which it is subject.
- 18.4 Transnet may terminate the Agreement at any time within 2 [two] months of becoming aware of a change of control of the Service Provider by notice in writing to the Service Provider. For the purposes of this clause, "control" means the right to direct the affairs of a company whether by ownership of shares, membership of the board of directors, agreement or otherwise.

- 18.5 Transnet may cancel any schedule or Work Order hereto at any time on giving the Service Provider 30 [thirty] days' written notice.
- 18.6 Notwithstanding this clause 18, either Party may cancel the Agreement without cause by giving 30 [thirty] days prior written notice thereof to the other Party.

### 19 CONSEQUENCE OF TERMINATION

- 19.1 Termination in accordance with clause 18 [Term and Termination] shall not prejudice or affect any right of action or remedy which shall have accrued or shall thereafter accrue to either Party and all provisions which are to survive the Agreement or impliedly do so shall remain in force and in effect.
- 19.2 On termination of the Agreement or a Work Order, the Service Provider will immediately deliver up, and procure that its Personnel will immediately deliver up to Transnet, all Deliverables and property belonging to Transnet [or, in the event of termination of a Work Order, such as is relevant to that Work Order] which may be in the possession of, or under the control of the Service Provider, and certify to Transnet in writing that this was been done.

- 19.6 If either Party [the Defaulting Party] commits a material breach of the Agreement and fails to remedy such breach within 30 [thirty] Business Days of written notice thereof, the other Party [hereinafter the Aggrieved Party], shall be entitled, in addition to any other rights and remedies that it may have in terms of the Agreement, to terminate the Agreement forthwith without any liability and without prejudice to any claims which the Aggrieved Party may have for damages against the Defaulting Party.

# 19.7 Should:

- a) the Service Provider effect or attempt to effect a compromise or composition with its creditors; or
- either Party be provisionally or finally liquidated or placed under judicial management,

Further, in the event that Transnet wishes a assign or novate the Agreement to any third party, the Service Provider agrees that it shall no junreasonably withhold or delay its consent to such assignment or novation and that it shall only be splitted to recover from Transnet any reasonable legal costs incurred by it as a direct result of such assignment or novation.

- 21.1 Neither Party shall have any claim against the other Party arising from any failure or delay in the performance of any obligation of either Party under the Agreement caused by an act of *force majeure* such as acts of God, file, head, war, strike, lockout, industrial dispute, government action, laws or regulations, rices, perforis n or civil disturbance, defaults, delays or discontinuance on the part of independent contractors, suppliers, or other circumstances or factors beyond the reasonable control of either Party, and to the extent that the performance of obligations of either Party hereunder is collated by virtue of the aforegoing, any period stipulated for any such performance shall be reasonably extended.
- 21.2 Each Park we takefall reasonable steps by whatever lawful means that are available, to resume full performance as soon as practicable and will seek agreement to modification of the relevant provides of the Agreement in order to accommodate the new circumstances caused by the act of *firce majeure*. If a Party fails to agree to such modifications proposed by the other Party within 90 kninety] days of the act of *force majeure* first occurring, either Party may thereafter terminate the Agreement with immediate notice.

### 25 DISPUTE RESOLUTION

25.1 Should any dispute of whatsoever nature arise between the Parties concerning the Agreement, the Parties shall try to resolve the dispute by negotiation within 10 [ten] Business Days of such dispute arising.

25.2 If the dispute has not been resolved by such negotiation, either of the Parties may refer the dispute to AFSA and notify the other carty accordingly, which proceedings shall be held in Johannesburg.

25.3 Such dispute shall be finally resolved in accordance with the rules of AFSA by an arbitrator or arbitrators appointed by AFSA.

25.4 This clause constitutes all irrevocable consent by the Parties to any proceedings in terms hereof, and neither of the Parties shall be entitled to withdraw from the provisions of this clause or claim at any such proceedings that it is not bound by this clause 25.

25.5 This chuse 25 is severable from the rest of the Agreement and shall remain in effect even if the Agreement is terminated for any reason.
