#### 2 BROAD-BASED BLACK ECONOMIC EMPC WERMENT [B-BBEE]

Transnet fully endorses and supports be Government's Broad-Based Black Economic Empowerment Programme and it would therefore orefor to do business with local business enterprises who share these same values. Transnet will accordingly allow a "preference" to companies who provide a valid B-BBEE Verification Certificate. All procurement transactions will be evaluated accordingly.

#### 2.1 B-BBEE Score and and Rating

As prescribed in texas of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its Regulations, Respondents are to note the following:

In this RFQ, Transnet will apply 80/20 preference point system prescribed in the PPPFA.

- Proposals will be evaluated on price which will be allocated 80 points and preference which will be allocated 20 points.
- The 80/20 preference point system applies where the acquisition of the Services will be less than R1 000 000.00. However, if the 80/20 preference point system is stipulated in this RFQ and all Bids received exceed R1 000 000.00, the RFQ will be cancelled.

In compliance with the Government Gazette No 34612, Notice No. 754 dated 23 September 2011, as from 1 October 2011 valid B-BBEE Verification Certificates must be issued by:

- (i) Verification Agencies accredited by the South African National Accreditation System [SANAS]; or
- (ii) Registered Auditors approved by the Independent Regulatory Board of Auditors [IRBA], in accordance with the approval granted by the Department of Trade and Industry.

Enterprises will be rated by such agencies based on the following:

#### (a) Large Enterprises [i.e. annual turnover greater than R35 million]:

Rating level based on all seven elements of the B-BBEE scorecard

- (b) Qualifying Small Enterprises QSE [i.e. annual turnover between R5 million and R35 million]:

Sufficient evidence to qualify as an EME would be a certificate (which may be in the form of a letter) from an auditor or accounting officer or a certificate from a Verification Agency accredited by SANAS. The certificate must confirm the company's turnover, black ownership / black female ownership, B-BBEE status level and validity date.

Transnet will accordingly allocate a maximum of **20 twen y] points** to the Respondent's final score based on an entity's B-BBEE scorecard rating.

#### CONTRACTUAL OBLIGATIONS

#### TO BE SUPPLIED BY TRANSNET FREIGHT RAIL

Jumbo rolls, toilet paper, Urinal P-trap mats, folded hand towels and liquid hand soap.

#### 2. TO BE SUPPLIED BY THE CONTRACTOR

Except where otherwise specified, the Contractor shall supply all labour, transport, vacuum cleaners, scrubbing/polishing machines, brooms, mops, buckets, dusters, rags, cleaning agents, refuse bags, necessary sign boards e.g. Wet floor/Slippery, PVC gloves with distinctive color is for various applications required for the carrying out and completion of the work included in this contract.

Only SABS approved cleaning agents are to be used in the execution of the antract

#### Note:

#### SITE BOOK

A site instruction book will be provided by the Contractor for the duration of the contract. This book is for the recording of site instructions and all events and conditions which may affect the progress of the work.

The Contractor shall make good to the satisfaction of Transnet any discrepancies recorded in the site diary book within 1 working day.

All cleaning chemicals and cleaning magninery to be clearly marked by the Contractor.

Maintain all equipment in good order so as to comply with Transnet's Occupational Health and Safety Standards

### 3. ELECTRICITY AND WATER

Water and electricity will be supplied free of charge by Transnet. A continuous supply of water and electricity can have a cot be guaranteed.

#### 4. PERSONNEL

#### Clean is must be:

- Be in possession of a valid S.A. identity document
  - Be resident in an area which is reasonably close to the place of work
- · Meet the physical requirements of cleaning duties
- Ensure that all personnel working under this contract are in good health and pose no risk to any Transnet employees.
- Comply with Transnet's security and emergency policies, procedures and regulations
- Ensure that all personnel are adequately trained prior to the commencement of the contract.
- Cleaners must be functionally literate, e.g. able to comprehend warning signs

#### 5. LABOUR

When a staff member is off sick or on leave, alternative arrangements must be made and only a trained/ qualified relief is to be on duty in the absentees place.

#### 6. UNIFORM CLOTHING

The Contractor shall provide cleaners with uniforms, which state the name of the Service Provider as well as the personnel's name and surname and that can be clearly identified from other Service Providers.

#### Note:

Provide all personnel working under this contract with adequate and appropriate PPE and clothing to ensure these items are worn at all times.

#### WORK SCHEDULE

After the tender has been awarded, every worker must have a job output describing in detail all duties to be performed by that person every day.

#### 8. PENALTY

A penalty of R200,00 per day will be applicable for each day a cleaner is not be dedicated site.

#### 9. SUPERVISION

It is noted that a Supervisor will be available as and when required to address any problems that may arise out of the service rendered and to carry out inspections of a weekly basis and a checklist be signed off by the Transnet Health and Safety Representative.

Staff administration to be handled by the contractor own personnel/supervisor on premises and not by Transnet personnel.

#### PAYMENT

Tax invoices shall be submitted to ether with a month-end statement. Payment against such month-end statement shall be made by Transpet within 30 (thirty) days after date of receipt by Transpet of the statement together with all undisputed Tax Invoices and supporting documentation.

#### 11. INDEMNITY CLAUSE

Transnet will not be hald re-onsible for any injuries incurred by the Contractor while rendering the service.

#### 12. SAFETY ON VORY SITE (ACT NUMBER 85 OF 1993)

### ENV RONMENT CONSERVATION ACT (ACT NO. 73 OF 1989)

#### 13. SUBSTANCE ABUSE

The OHSA (Act 85 of 1993) clearly states in the Safety Regulations no. 2A "INTOXICATION" An employer or user, as the case may be, shall not permit any person who appears to be under the influence of intoxicating liquor or drugs, to enter or remain at a workplace". Transnet Freight Rail enforces this legislation by means of its Substance Abuse Policy, and therefore reserves the right to do substance abuse testing on anyone who enters their premises.

#### 14. SMOKING POLICY

Transnet Freight Rail has a Smoking Policy – it must be adhered to be all public places, which includes all Transnet Freight Rail's buildings and vehicles.

#### 15. CHEMICAL AND TOXIC SUBSTANCES

All chemicals brought to the site shall be kept in **properly labe** ed safe containers. Empty containers must be destroyed – punch holes in containers to prevent release for other purposes.

Material Safety Data Sheets to be provided for fiequent use and high risk (hazardous) chemicals.

#### Note:

Certificates indicating that employees are trained and competent in the use of hazardous chemical substances and clearing materials to be submitted within seven(7) days after notification of award of business.

#### 16. MEDICAL SURVEILLANCE

Employees must be on medical urveillance and records available on safety file.

#### SUPPLIER CODE OF CONDUCT

#### Prohibition of bribes, kickbacks, unless and other corrupt practices

# SAFETY ARRANGEMENTS AND PROCEDURAL COMPLIANCE WITH THE OCCUPATIONAL HEALTH AND SAFETY ACT (ACT 85 OF 1993) AND APPLICABLE REGULATIONS

#### 1. General

- 1.1 The Contractor and Transnet Limited (hereinafter referred to as "Transnet") are individual employers, each in its own right, with their respective duties and obligations set out in the Occupational Health and Safety Act, Act 85 of 1993 (the Act) and applicable Regulations.
- 1.2 The Contractor accepts, in terms of the General Conditions of Contract and in terms of the Act, his obligations as an employer in respect of all persons in his employ, other persons on the premises or the Site or place of work or on the work to be executed by him, and and his control. He shall, before commencement with the execution of the contract work, comply with the provisions set out in the Act, and shall implement and maintain a Health and Safety Plan as described in the Construction Regulations, 2003 and as approved by Transnet, on the Site and place of work or the duration of the Contract.
- 1.3 The Contractor accepts his obligation to complying fully with the Act and applicable Regulations notwithstanding the omission of some of the provisions of the Act and the Regulations from this document.
- Transnet accepts, in terms of the Act, its obligations as an employer of its own employees working on or associated with the site or place of work, and the Contractor and Technical Officer or his deputy shall at all times, co-operate in respect of the beath and safety management of the site, and shall agree on the practical arrangements and proced res to the implemented and maintained during execution of the Works.
- 1.5 In the event of any discrepancies between any legislation and this specification, the applicable legislation will take precedence.

#### 2. Definitions

- 2.1 In this Specification my word or expression to which a meaning has been assigned in the Construction Regulations, shall have the meaning so assigned to it, unless the context otherwise indicates: -
- 2.2 The work included in this Contract shall for the purposes of compliance with the Act be deemed to be "Construction Work", which, in terms of the Construction Regulations, 2003 means any work in contact on w.m: -
  - (a) the erection, maintenance, alteration, renovation, repair, demolition or dismantling of or addition to a building or any similar structure;
  - (b) the installation, erection, dismantling or maintenance of fixed plant where such work includes the risk of a person falling;
  - (c) the construction, maintenance, demolition or dismantling of any bridge, dam, canal, road, railway, runway, sewer or water reticulation system or any similar civil engineering structure; or
  - (d) the moving of earth, clearing of land, the making of an excavation, piling, or any similar type of work;
- 2.3 "competent person" in relation to construction work, means any person having the knowledge, training and experience specific to the work or task being performed: Provided that where appropriate qualifications and training are registered as per the South African Qualifications Authority Act, 1995 these qualifications and training shall be deemed to be the required qualifications and training;
- 2.4 "contractor" means principal contractor and "subcontractor" means contractor as defined by the Construction Regulations, 2003.
- 2.5 "fall protection plan" means a documented plan, of all risks relating to working from an elevated position, considering the nature of work undertaken, and setting out the procedures and methods applied to eliminate the risk;

- 2.6 "health and safety file" means a file, or other record in permanent form, containing the information required to be kept on site in accordance with the Act and applicable Regulations;
- 2.7 "Health and Safety Plan " means a documented plan which addresses the hazards identified and include safe work procedures to mitigate, reduce or control the hazards identified;
- 2.8 "Risk Assessment" means a programme to determine any risk associated with any hazard at a construction site, in order to identify the steps needed to be taken to remove, reduce or control such hazard;
- 2.9 "the Act" means the Occupational Health and Safety Act No. 85 of 1993.

## 3. Procedural Compliance

- 3.1 The Contractor who intends to carry out any construction work shall before carrying out such work, notify the Provincial Director in writing if the construction work:-
  - (a) Includes the demolition of a structure exceeding a height of 3 metres; or
  - (b) includes the use of explosives to perform construction work; or
  - (c) includes the dismantling of fixed plant at a beight greater than 3m,

and shall also notify the Provincial Director in writing when the construction work exceeds 30 days or will involve more than 300 person days of construction work and if the construction work:-

- (a) includes excavation work desper can 11; or
- (b) includes working at a heigh greater than 3 metres above ground or a landing.
- The notification to the Provincia Director shall be on a form similar to Annexure A of the Construction Regulations, 2003, also shows in Annexure 1 of this Specification. The Contractor shall ensure that a copy of the completed notification form is kept on site for inspection by an inspector, Technical Officer or employee.
- 3.3 The Contractor shall, in accordance with the Act and applicable Regulations, make all the necessary appointments of competent persons in writing on a form similar to Annexure 2 of this Specification and deliver copies the rechnical Officer. Copies should also be retained on the health and safety file.
- 3.4 Subcontractor shall also make the above written appointments and the Contractor shall deliver copies the roof othe Technical Officer.
- 3.5 In the case of a self-employed Contractor or any subcontractor who has the appropriate competencies and supervises the work himself, the appointment of a construction supervisor in terms of regulation 6.1 of the Construction Regulations, 2003 will not be necessary. The Contractor shall in such a case execute and sign a declaration, as in Annexure 3, by which he personally undertakes the duties and obligations of the "Chief Executive Officer" in terms of section 16(1) of the Act.
- 3.6 The Contractor shall, before commencing any work, obtain from the Technical Officer an access certificate as in Annexure 4 executed and signed by him, permitting and limiting access to the designated site or place of work by the Contractor and any subcontractors under his control.
- 3.7 Procedural compliance with Act and Regulations, as above, shall also apply to any subcontractors as employers in their own right. The Contractor shall furnish the Technical Officer with full particulars of such subcontractors and shall ensure that they comply with the Act and Regulations and Transnet's safety requirements and procedures.

### 4. Special Permits

Where special permits are required before work may be carried out such as for hotwork, isolation permits, work permits and occupations, the Contractor shall apply to the Technical Officer or the relevant authority for such permits to be issued. The Contractor shall strictly comply with the conditions and requirements pertaining to the issue of such permits.

# Health and Safety Programme

- The Tenderer shall, with his tender, submit a Health and Safety Programme setting out the practical arrangements and procedures to be implemented by him to ensure compliance by him with the Act and Regulations and particularly in respect of: -
  - (i) The provision, as far as is reasonably practical, of a working environment that is safe and without risk to the health of his employees and subcontractors in terms of section 8 of the Act;
  - the execution of the contract work in such a manner as to ensure in terms of section 9 of the Act that persons other than those in the Contractor's employment, who may be directly affected by the contract work are not thereby exposed to hazards to their health and safety;
  - (iii) ensuring, as far as is reasonably practical, in terms of section 37 of the Act that no employee or subcontractor of the Contractor does or omits to do any act which would be an offence for the Contractor to do or omit to do.
- The Contractor's Health and Safety Programme shall be based on a risk as essment in respect of the hazards to health and safety of his employees and other persons most his control that are associated with or directly affected by the Contractor's activities in performing the contract work and shall establish precautionary measures as are reasonable and practical in projecting the safety and health of such employees and persons.
- 5.3 The Contractor shall cause a risk assessment contemplated in clause 5.2 above to be performed by a competent person, appointed in writing, before competent of any Construction Work and reviewed during construction. The Risk Assessments shall firm part of the Health and Safety programme to be applied on the site and shall include at least the nowing:
  - (a) The identification of the risks and hazar's that persons may be exposed to;
  - (b) the analysis and evaluation of the azards identified;
  - (c) a documented Health and Safety Plan, including safe work procedures to mitigate, reduce or control the risks identified
  - (d) a monitoring and review plan.
- 5.4 The Health and Tafe Plan shall include full particulars in respect of: -
  - (a) The salest management structure to be instituted on site or place of work and the names of the Contractor's health and safety representatives and members of safety committees where a solicy ole;
  - the safe working methods and procedures to be implemented to ensure the work is performed in compliance with the Act and Regulations;
  - (c) the safety equipment, devices and clothing to be made available by the Contractor to his employees;
  - (d) the site access control measures pertaining to health and safety to be implemented;
  - (e) the arrangements in respect of communication of health and safety related matters and incidents between the Contractor, his employees, subcontractors and the Technical Officer with particular reference to the reporting of incidents in compliance with Section 24 and General Administrative Regulation 8 of the Act and with the pertinent clause of the General Conditions of Contract forming part of the Contract and
  - (f) the introduction of control measures for ensuring that the Safety Plan is maintained and monitored for the duration of the Contract.
- 5.4 The Health and Safety programme shall be subject to the Technical Officer's approval and he may, in consultation with the Contractor, order that additional and/or supplementary practical arrangements and procedures be implemented and maintained by the Contractor or that different working methods or safety equipment be used or safety clothes be issued which, in the Technical Officer's opinion, are necessary to ensure full compliance by the Contractor with his obligations as an employer in terms of the Act and Regulations. The Technical Officer or his deputy shall be allowed to attend meetings of the Contractor's safety committee as an observer.

- 5.5 The Contractor shall take reasonable steps to ensure that each subcontractor's Health and Safety Plan is implemented and maintained on the construction site: Provided that the steps taken, shall include periodic audits at intervals mutually agreed to between the them, but at least once every month.
- 5.6 The Contractor shall stop any subcontractor from executing any construction work, which is not in accordance with the Contractor's, and/or subcontractor's Health and Safety Plan for the site or which poses a threat to the health and safety of persons.
- 5.7 The Contractor shall ensure that a copy of the Health and Safety Plan is available on site for inspection by an inspector, Technical Officer, agent, subcontractor, employee, registered employee organisation, health and safety representative or any member of the health and safety committee.
- 5.8 The Contractor shall consult with the health and safety committee or, if no health and safety committee exists, with a representative group of employees, on the development, monitoring and review of the Risk Assessment.
- 5.9 The Contractor shall ensure that all employees under his control are informed, instructed and trained by a competent person regarding any hazard and the related work proordure, before any work commences, and thereafter at such times as may be determined in the Ris Assersment.
- The Contractor shall ensure that all subcontractors are informed agarding any hazard as stipulated in the Risk Assessment before any work commences, and then after at such times as may be determined in the 5.10 Risk Assessment.
- The Contractor shall ensure that all visitors to a struction site undergoes health and safety induction pertaining to the hazards prevalent on ne si and shall be provided with the necessary personal protective equipment.

#### 6. **Fall Protection Plan**

- 6.1.1 In the event of the risk and bazard identification, as required in terms of clause 5.3 of this Specification, revealing risks relating to working from an elevated position the contractor shall cause the designation of a competent person, responsible for the preparation of a fall protection plan;
   6.2 The Contractor shall implement, maintain and monitor the fall protection plan for the duration of Contract.
- The Contractor shall also take such steps to ensure the continued adherence to the fall protection plan.
- 6.3 The fall protection plan shall iclude:-
  - (a) A Rick Assessment of all work carried out from an elevated position;
  - (b cocedures and methods to address all the identified risks per location;
  - the evaluation of the employees physical and psychological fitness necessary to work at elevated positions:
  - (d) the training of employees working from elevated positions; and
  - (e) the procedure addressing the inspection, testing and maintenance of all fail protection equipment.

#### 7. Hazards and Potential Hazardous Situations

The Contractor and the Technical Officer shall immediately notify one another of any hazardous or potentially hazardous situations which may arise during performance of the Contract by the Contractor or any subcontractor and, in particular, of such hazards as may be caused by the design, execution and/or location and any other aspect pertaining to the contract work.

#### 8. Health and Safety File

8.1 The Contractor shall ensure that a health and safety file is opened and kept on site and shall include all documentation required as per the Act and applicable regulations, and made available to an inspector, the Technical Officer, or subcontractor upon request.

- 8.2 The Contractor shall ensure that a copy of the both his Health and Safety Plan as well as any subcontractor's Health and Safety Plan is available on request to an employee, inspector, contractor or the Technical Officer.
- 8.3 The Contractor shall hand over a consolidated health and safety file to the Technical Officer upon completion of the Construction Work and shall in addition to documentation mentioned in the Act and applicable Regulations include a record of all drawings, designs, materials used and other similar information concerning the completed structure.
