2 Broad-Based Black Economic Empowerment [B-BBEE]

Transnet fully endorses and supports the Coveniment's Broad-Based Black Economic Empowerment Programme and it would therefore prefer to an bisiness with local business enterprises who share these same values. 2.1 B-BBEE Scorecard Rating
