2.1 **B-BBEE Scorecard and Rate**

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of s, Respondents are to note the following: 2000 and its Peguia io

- Transnet will apply the 80/20 preference point system prescribed in the PPPFA.
- sals III be evaluated on price which will be allocated 80 points and preference which will Prop be an ated 20 points.
- 80/20 preference point system applies where the acquisition of the Goods will be less than R1 000 000.00. However, if the 80/20 preference point system is stipulated in this RFO and all Bids received exceed R1 000 000.00, the RFQ will be cancelled.

In compliance with the Government Gazette No 34612, Notice No. 754 dated 23 September 2011, as from 1 October 2011 valid B-BBEE Verification Certificates must be issued by:

- Verification Agencies accredited by the South African National Accreditation System (i) [SANAS]; or
- (ii) Registered Auditors approved by the Independent Regulatory Board of Auditors [IRBA], in accordance with the approval granted by the Department of Trade and Industry.

Enterprises will be rated by such agencies based on the following:

- a) **Large Enterprises** [i.e. annual turnover greater than R35 million]:
 - Rating level based on all seven elements of the B-BBEE scorecard

- b) **Qualifying Small Enterprises QSE** [i.e. annual turnover between R5 million and R35 million]:
 - Rating based on any four of the elements of the B-BBEE scorecard
- c) **Exempted Micro Enterprises EME** [i.e. annual turnover less than R5 million]:

In accordance with B-BBEE Codes of Good Practice [Statement 000, Section 4], any enterprise with an annual total revenue of R 5 million or less qualifies as an EME.

- Automatic rating of B-BBEE Level 4 irrespective of race or ownership
- Black ownership greater than 50% or Black Women ownership greater than 50% automatically qualify as B-BBEE Level 3

Sufficient evidence to qualify as an EME would be a certificate (whith may be in the form of a letter) from an auditor or accounting officer or a certificate from a lerification Agency accredited by SANAS. The certificate must confirm the company's turnover, black ownership / black female ownership, B-BBEE status level and validity date.

Respondents are required to furnish proof of the above to Translet. [i.e. a valid detailed scorecard as stipulated above in respect of Large Enterprise and USEs, or a valid certificate in respect of EMEs].

Transnet will accordingly allocate a maximum of **20 [twenty] points** to the Respondent's final score based on an entity's B-BBEE scorecald rating. [Refer <u>Annexure A – B-BBEE Preference</u> <u>Points Claim Form</u> for further details].

N.B. Failure to submit a B-BREE certific te, which is valid as at the Closing Date of this RFQ, will result in a score of zero being clocated for B-BBEE.
